# APPLY NOW FOR PENNSYLVANIA'S 2024-25 ELK HUNTING SEASONS

The Pennsylvania Board of Game Commissioners preliminarily approved three elk hunting seasons (archery, general, and late) for 2024-25.

Apply for just \$11.97 per season or \$35.91 for all three at huntfish.pa.gov or at any license issuing agent. View hunt zone descriptions at pgc.pa.gov.

Final seasons and bag limits will be approved at the April board meeting. Changes can be made to application preferences (hunt zones and sex) until the application period closes on Sunday, July 14, 2024.

Drawings for all three seasons will be held on Saturday, July 27, 2024, at the Keystone Elk Country Alliance's Elk Expo, in Benezette, PA.

Springtime means wildlife like rabbit kits, nestling songbirds, and deer fawns are being born. If you spot newborn or young wildlife, please do not disturb them. While some young animals might appear to be abandoned, many wildlife parents will leave their young alone and hidden to avoid attracting predators, only coming back to nurse them a few times a day. Although humans have the best intentions, intervening can do more harm than good.

White-tailed fawns, for example, have white spots mimicking the sun hitting the ground through trees to help them stay hidden as they bed down for the first several weeks of life. They're born scent-free, so mothers stay away to prevent spreading their scent and drawing in predators. They only interact with their fawns two or three times a day to nurse. This is their best defense strategy throughout a fawn's first few weeks! Generally, a healthy fawn that hasn't been abandoned will have its ears up, and its backend will be clean.

Follow these tips to help wildlife stay wild this spring:



- · Don't feed or water these animals.
- · Keep your pets away from them.
- Never take young wildlife home or inside your house.

## CALLING ALL TURKEY HUNTERS

Pennsylvania is home to the most passionate turkey hunters in the nation — more than 170,000 hit the woods each spring!

Spring gobbler season runs statewide from May 4-31, 2024. A special season for eligible junior hunters, with required license, as well as mentored hunters 16 and under is on Saturday, April 27, 2024.

Only birds with visible beards are legal to harvest during the spring season, and hunting is permitted by calling only. Hunters are not required to wear fluorescent orange during the spring turkey season, but it is recommended while moving.

#### STAY SAFE IN THE TURKEY WOODS

Keep these important tips in mind to stay safe while hunting:

- Positively ID your target. Be sure the turkey and its beard are plainly visible before pulling the trigger.
- Never stalk a turkey. Any movement or sounds you think are a turkey could be another hunter.
- Protect your back. Select a large tree, rock, or other natural barrier to place at your back while calling.
- Shout "STOP" to alert approaching hunters. Never move, wave, or make turkey sounds to alert others of your position.
- Be seen. Wear or display fluorescent orange, especially when moving.



#### REPORT YOUR SPRING HARVEST

Make your harvest count! Successful turkey hunters must immediately tag the bird before moving it from the harvest site and are required by law to report it to the Game Commission.

Hunters have the option to report three ways: online at <u>pgc.pa.gov</u>, by calling 1-800-838-4431, or by mailing in a harvest card.

The data collected is critical to wildlife management decision-making processes for years to come.

#### **BOBWHITE QUAIL ARE BACK**

After years of intensive habitat work, the Pennsylvania Game Commission released 76 bobwhite quail on the grounds of Letterkenny Army Depot in Frankling County in March, with one more released planned.

The birds — which should increase in number exponentially over the course of the spring breeding season — are the final brick in a foundation the Game Commission began laying more than a decade ago.



Bobwhite quail are native to the Keystone State, and all 67 counties held populations during the mid-1800s. After 25 years of extirpation due to habitat loss and other factors, the iconic birds are back. Visit <u>pgc.pa.gov</u> to learn more about bobwhite quail and this historical reintroduction.



#### PRELIMINARY 2024-25 HUNTING & TRAPPING SEASONS APPROVED

The Pennsylvania Board of Game Commissioners met Saturday, Jan. 27, at the agency's headquarters in Harrisburg. The board gave preliminary approval to the 2024-25 hunting and trapping seasons and bag limits.

The public may offer comments on all proposed 2024-25 seasons and bag limits, as well as other board actions, between now and the board's meeting on April 12-13, when 2024-25 seasons and bag limits will be finalized and antierless deer license allocations will be determined.

# PRESCRIBED FIRE FOR WILDLIFE HABITAT

The Pennsylvania Game Commission uses prescribed fire at the right place, at the right time, and at the right intensity to strategically improve the resilience of forests, grasslands, and shrublands. This ultimately benefits wildlife through the long-term health of their habitats.

Most prescribed burns take place under ideal springtime conditions, and contrary to common misconception, this has very little negative impact to wildlife in the short-term.

With the addition of these new wardens, the PGC is even better equipped to fulfill its mission of managing and protecting wildlife and their habitats while promoting hunting and trapping for both current and future generations.

#### **NEARLY 1,000 STUDENTS COMPETE IN NASP TOURNAMENTS**



Roughly 100,000 arrows flew downrange at Spooky Nook Sports in Lancaster County as nearly 1,000 students representing more than 50 school districts across the Keystone State competed in the 2024 National Archery in the Schools Program (NASP) Pennsylvania State Bullseye and IBO 3D tournaments on March 22.

Upper Dauphin Area High School was named Bullseye state champion for the third consecutive year. Montrose Area High School claimed the top spot in IBO 3D, with Montrose's Madilynn Rhinevault finishing first for high school girls in both Bullseye and IBO 3D. Casey Keiter of Line Mountain won both state championships for high school boys.
