BUREAU OF WILDLIFE MANAGEMENT

PROPOSED RULE MAKING

A. Amend 58 Pa. Code § 141.28.

Commentary: Pheasant hunting within a Wild Pheasant Recovery Area (WPRAs) is currently limited to youth participants who are authorized by permit to hunt in designated pheasant hunt zones within the Central Susquehanna WPRAs only. Youth participants are selected for WPRAs hunting access permits through a raffle conducted by the Commission. The Commission has determined that these restrictions are no longer necessary because the biological impacts of hunting on wild pheasant populations can be adequately controlled by limiting harvest to male pheasants and by following an annual executive order process specifying whether a season is to be opened and (if opened) the season length and bag limit that will apply. Therefore, the Commission is proposing to amend § 141.28 (relating to wild pheasant recovery areas) to eliminate age restriction and permit requirements and provide the Director the authority to annually designate WPRAs to be opened to hunting and establish appropriate season date(s) and bag limits. As a result of this regulatory change, all individuals eligible to hunt pheasants statewide would also be allowed to participate in pheasant hunting within WPRAs, subject to landowner permission.

CHAPTER 141. HUNTING AND TRAPPING

Subchapter B. SMALL GAME

§ 141.28. Wild pheasant recovery areas.

* * * * *

(b) *Prohibitions.* It is unlawful to:

(1) Release artificially propagated pheasants any time within any area designated as a WPRAs.

(2) Hunt pheasants within any area designated as a WPRAs, except the Director may authorize limited [youth] pheasant hunting opportunities [by Commission-issued access permit in the Central Susquehanna WPRAs] in one or more WPRAs. During any year [youth] pheasant hunting opportunities are authorized in [the Central Susquehanna WPRAs] one or more WPRAs, the Director will [establish the number of hunting access permits to be issued, a manner of distribution for a limited number of access permits to be raffled off by an organization promoting pheasant recovery efforts within this Commonwealth, and designate one or more pheasant hunt zones within the WPRAs prior to the opening of the earliest established youth pheasant season. The Director or a designee will establish the application deadline and the date, time and location for the random drawing of applications for the issuance of any remaining limited youth pheasant hunting access permits within the Central Susquehanna WPRAs. Limited youth

~~pheasant hunting access permits are not transferrable. A pheasant hunting access permit shall be signed and carried on person when hunting or taking pheasants within the Central Susquehanna WPA]~~ designate the WPA(s) that the season will be established, the date(s) of the season, and the daily bag limit.

B. Amend 58 Pa. Code § 139.4.

Commentary:

To effectively manage the wildlife resources and provide hunting and trapping opportunities in this Commonwealth during the upcoming license year, the Commission is proposing to amend § 139.4 (relating to seasons and bag limits for the license year) to provide updated seasons and bag limits for the 2024-2025 license year. The 2024-2025 seasons and bag limits have been amended to reflect current available scientific data, population and harvest records, field surveys and professional staff observations, as well as recommendations received from staff, organized sporting groups, members of the agricultural community and others interested in the management of the wildlife resources of this Commonwealth.

For small game, eligibility to participate in the early October pheasant season segment would be expanded to include mentored hunters of all ages, and the Executive Director would be provided with increased flexibility to authorize pheasant hunting within Wild Pheasant Recovery Areas.

For wild turkey, fall season length changes are proposed for numerous Wildlife Management Units based on analysis of long-term turkey population trends and results of turkey hunter surveys. Season length would be increased in 11 WMUs and WMU 5A (previously closed to fall hunting) would be opened for a 3-day season. Season length would be reduced in 2 WMUs (3D and 4C).

For black bear, the October muzzleloader season is proposed to be shortened to 3 days to reduce harvest rates on female bears and thereby promote stabilization of the bear population.

For furbearers, WMU 2D is proposed to be opened to bobcat hunting and trapping because habitat and population data indicate that this unit can support sustainable bobcat harvest. Also, the fisher trapping season is proposed to be increased by 1 week in all WMUs open to fisher harvest to provide additional opportunity and to make fisher and bobcat trapping seasons concurrent.

No changes are proposed for elk or white-tailed deer seasons. However, it is likely that analysis of license sales and harvest data following the January meeting will indicate a need for additional antlerless deer hunting opportunity in Chronic Wasting Disease WMUs where antlerless license allocations did not sell out and/or antlerless harvest goals were not met in 2023-24.

Except as further restricted by this chapter, the seasons, bag limits, hunting hours and hunting regulations for migratory game birds shall conform to regulations adopted by the United States Secretary of the Interior under authority of the Migratory Bird Treaty Act (16 U.S.C.A. §§ 703-712) as published in the *Federal Register* on or about February 28 of each year.
 Exceptions:

(a) Hunting hours in § 141.4 (relating to hunting hours).

(b) Nontoxic shot as approved by the Director of the United States Fish and Wildlife Service is required for use statewide in hunting and taking of migratory waterfowl.

(c) Hunting on Sunday not authorized.¹

D. American Marten Reintroduction and Management Plan

Commentary: The American marten (*Martes americana*) is a furbearer once commonly found in portions of Pennsylvania but extirpated from the Commonwealth in the early 1900s due to deforestation and unregulated harvest.

In accordance with Goal 1.3b of the Pennsylvania Game Commission Strategic Plan 2020-2023 and as authorized by the Commission at its July 9, 2022 meeting, Commission staff developed an American Marten Reintroduction and Management Plan for Pennsylvania. The plan outlines a long-term, 10-year strategy, to translocate the species back to the state and then conduct long-term monitoring to evaluate the reintroduction. Communication strategies, partner engagement, costs, and timelines are also included.

At its September 16, 2023 meeting, the Commission authorized release of the proposed American marten reintroduction and management plan for a 60-day public comment period. All comments have been considered and appropriate revisions to the plan have been made. The Bureau of Wildlife Management is requesting final acceptance of the 2024-2033 marten reintroduction and management plan.

Action:

E. Black Bear Management Plan – 5-Year Revision

Commentary: The black bear (*Ursus americanus*) is a valuable resource in Pennsylvania. A comprehensive plan for managing the bear resource was first approved in 2006, with the mission statement to maintain healthy black bear populations in suitable habitats throughout the Commonwealth that provide hunting and recreational viewing opportunities, without human-bear conflicts exceeding levels acceptable to citizens of Pennsylvania. The Commission has developed a 5-year (2024-2029) revision to the bear management plan, maintaining the original mission statement while updating background information, objectives, and strategies to reflect current scientific knowledge and stakeholder input.

At its September 16, 2023 meeting, the Commission authorized release of the proposed revised black bear management plan for a 60-day public comment period. All comments have been considered and appropriate revisions to the plan have been made. The Bureau of Wildlife Management is requesting final acceptance of the 2024-2029 black bear management plan.

Action:

F. Snowshoe Hare Management Plan

Commentary: Due to growing public concern for the apparent decline of snowshoe hares (*Lepus americanus*) in Pennsylvania and the potential of this species to benefit from focused habitat management, the Commission has developed a comprehensive snowshoe hare conservation and management plan to maintain or increase snowshoe hare populations and their habitat within the Commonwealth of Pennsylvania for current and future generations. The management plan provides a comprehensive summary of snowshoe hare biology, historic and current status in Pennsylvania, and habitat and harvest management strategies. The plan also provides supporting objectives and strategies to achieve snowshoe hare specific goals related to population monitoring, assessment, and management related to habitat and harvest.

At its September 16, 2023 meeting, the Commission authorized release of the proposed snowshoe hare management plan for a 60-day public comment period. All comments have been considered and appropriate revisions to the plan have been made. The Bureau of Wildlife Management is requesting final acceptance of the snowshoe hare management plan.

A. Amend 58 Pa. Code § 141.4.

Commentary: The Commission is proposing to amend § 141.4 (relating to hunting hours) to replace the current hunting hours table and migratory bird hunting hours table to accurately reflect the dates and hours of legal hunting for the 2024-2025 hunting/trapping license year.

CHAPTER 141. HUNTING AND TRAPPING

Subchapter A. GENERAL

§ 141.4. Hunting hours.

Except as otherwise provided, wild birds and mammals may be hunted 1/2 hour before sunrise to 1/2 hour after sunset.

B. Amend 58 Pa. Code § 141.18.

Commentary: To effectively manage the wildlife resources of this Commonwealth, the Commission, at its September 16, 2023 meeting, amended § 141.18 (relating to permitted devices) to authorize electronic devices used to disturb water with the purpose of preventing ice formation. This amendment is now before the Commission for final adoption.

CHAPTER 141. HUNTING AND TRAPPING

Subchapter A. GENERAL

§ 141.18. Permitted devices.

Notwithstanding the prohibitions in § 141.6 (relating to illegal devices), the following devices may be used to hunt or take wildlife:

(1) Firearms that use an electronic impulse to initiate discharge of ammunition. This provision is not intended to authorize use of these devices when these firearms are otherwise prohibited devices for the applicable hunting or trapping season.

* * * * *

(11) Electronic hand-held and firearm-mounted night-vision and infrared optics used solely for furbearer hunting.

(12) Electronic devices used to disturb water for the purpose of preventing ice formation.

C. Amend 58 Pa. Code § 135.2.

Commentary: To effectively manage the wildlife resources of this Commonwealth, the Game Commission, at its September 16, 2023 meeting, amended § 135.2 to prohibit any person from using or possessing a controlled substance or drug paraphernalia on Hunter Access Properties. A violation of this provision will be graded as a summary offense of the fifth degree carrying a potential fine of \$100-\$200. This amendment is now before the Commission for final adoption.

CHAPTER 135. LANDS AND BUILDINGS

Subchapter A. GENERAL PROVISIONS

§ 135.2. Unlawful actions.

In addition to the prohibitions in the act on lands, waters or buildings under Commission ownership, lease, agreement, control or jurisdiction, it is unlawful, except with the permission of the person in charge of the lands, or the written permission of the Director to:

- (1) Camp or use campsites.
- (2) Plant, gather, cut, dig, remove or otherwise injure plants or parts thereof, including trees, shrubs, vines, flowering plants, cultivated crops, mushrooms and fruits of berry-producing plants.
- (3) Travel on lands by means of vehicle or conveyance propelled by motorized power. This provision is not intended to restrict travel by certain devices used for persons with mobility disabilities as specifically authorized under Subchapter C (relating to State game lands).
- (4) Swim in a dam, pond, lake or stream.
- (5) Injure, destroy or cause damage to property--real, personal or mixed.
- (6) Remove or attempt to remove any manmade or natural object except wildlife and fish lawfully taken. Objects which may not be removed include animals, rocks, minerals, sand and historical or archaeological artifacts.
- (7) Participate in, become a part of, contribute to or engage in disorderly conduct as defined in 18 Pa.C.S. §§ 5503 and 5505 (relating to disorderly conduct; and public drunkenness).
- (8) Kindle, use or maintain an open fire.
- (9) Travel on roads open to vehicular travel with vehicle or conveyance propelled by motorized power which is not licensed or authorized for operation on a public highway under 75 Pa.C.S. (relating to the Vehicle Code).
- (10) Violate, fail or neglect to follow instructions posted on signs authorized by the Director.
- (11) Travel by mechanical or motorized conveyance or ride animals on newly constructed, seeded or planted roads, or other areas, when posted against the travel.
- (12) Possess, maintain, operate, occupy or travel by snowmobile or ATV in a manner not in accordance with the standards in 75 Pa.C.S. Chapter 77 (relating to Snowmobile and All-Terrain Vehicle Law).

(13) Construct, place, maintain, occupy, use, leave or abandon structures or other tangible property, except in the manner otherwise authorized and limited by § 135.41(c)(11) (relating to State game lands).

(14) Use or possess a controlled substance or drug paraphernalia as defined or classified under The Controlled Substance, Drug, Device and Cosmetic Act (35 P. S. §§ 780-101-780-144).

D. Amend 58 Pa. Code § 141.67.

Commentary: To effectively manage the wildlife resources of this Commonwealth, the Commission, at its September 16, 2023 meeting, amended § 141.67 (relating to furbearer seasons) to prohibit the hunting of any furbearer using a dog during the overlap with any regular firearms deer season or regular firearms bear season. This amendment is now before the Commission for final adoption.

ANNEX “A”

CHAPTER 141. HUNTING AND TRAPPING

Subchapter D. FURBEARERS

§ 141.67. Furbearer seasons.

(a) *Permitted devices.* It is lawful to hunt or take furbearers during any furtaking season with the following devices:

(1) A manually operated or semiautomatic rifle or manually operated handgun that propels single-projectile ammunition.

(2) A manually operated or semiautomatic, centerfire shotgun or muzzleloading shotgun. The firearm must be 10 gauge or less, that propels single-projectile ammunition or multiple-projectile shotgun ammunition not larger than # 4 buckshot. The centerfire shotgun's magazine capacity may not exceed two rounds. The shotgun's total aggregate ammunition capacity may not exceed three rounds.

(3) A muzzleloading rifle or handgun that propels single-projectile ammunition.

(4) A bow and arrow.

(5) A crossbow and bolt.

(6) A manually operated or semiautomatic air rifle or manually operated air handgun .22 caliber or larger that propels single-projectile pellet or bullet ammunition. BB ammunition is not authorized.

(7) A leg-hold trap, except as prohibited under section 2361(a)(8) of the act (relating to unlawful acts concerning taking of furbearers).

(8) A body-gripping trap, except as prohibited under section 2361(a)(11) of the act.

(9) A cable restraint device authorized by § 141.66 (relating to cable restraints).

(10) A snare, except as prohibited under § 141.62(b) (relating to beaver and otter trapping).

(11) A cage or box trap, except as prohibited under section 2361(a)(17) of the act.

(12) *A raptor.* The raptor shall be lawfully possessed under a falconry permit under section 2925 of the act (relating to falconry permits).

(b) *Prohibitions.* While hunting furbearers during any furbearer hunting or trapping season, it is unlawful to:

(1) Use or possess multiple-projectile shotgun ammunition larger than # 4 buckshot, except as authorized under section 2525 of the act (relating to possession of firearm for protection of self or others).

(2) Use or possess a device or ammunition not provided for in the act or in this section, except as authorized under section 2525 of the act.

(3) Use any firearm, other than authorized in this paragraph, to dispatch legally trapped furbearers during the overlap with the regular or special firearms deer seasons:

(i) A manually operated or semiautomatic rimfire rifle or manually operated rimfire handgun .22 caliber or less.

(ii) A manually operated or semiautomatic air rifle or manually operated air handgun between .177 and .22 caliber, inclusive, that propels single-projectile pellet or bullet ammunition. BB ammunition is not authorized.

(4) Hunt any furbearer using a dog during the overlap with any regular firearms deer season or regular firearms bear season.

Commentary: Natural Lands is offering 22.9+/- acres of land in Haycock Township, Bucks County adjoining State Game Land No. 157 (Exhibit RED 10). The option price is \$400 per acre to be paid from the Game Fund. Natural Lands' acquisition of the property is contingent upon them receiving funding through partnership grants provided by the Pennsylvania Department of Conservation and Natural Resources (DCNR) and the United States Fish and Wildlife Service through the Highlands Conservation Act (HCA). Covenants, conditions, and restrictions associated with these funding sources will be required to accept the property. Access is through existing State Game Land No. 157.

Because the HCA funds are payable to the Commonwealth only as a reimbursement, the Commonwealth has determined the most expeditious way to move forward is for the Commission to accept a subaward for the federal funds from DCNR, provide the HCA award amount to Natural Lands from the Commission's restricted revenue account set up through Treasury for "Other Cost Sharing Funds," and then directly accept the HCA federal reimbursement amount back into the restricted revenue account. This has the double benefit of being efficient, as well as ensuring federal dollars can be tracked directly to the acquisition project as intended by the HCA. The net effect to the restricted revenue account or the Game Fund is \$0.00. To accomplish this, the Board of Commissioners must approve the use of the restricted revenue account, payment from the account, and the subsequent acceptance of the federal HCA funds deposited into the account.

Notational Vote

Contract L-3842, State Game Land No. 302, Washington County

Commentary: On October 5, 2023, the Board of Commissioners approved, by notational vote, the deposit of \$158,741 into the restricted revenue account to be used for the future purchase of lands to mitigate the temporary loss of wildlife resources and/or recreational values. CNX Gathering LLC (CNX) offered \$158,741 in exchange for a Special Use Permit (SUP) granting the temporary privilege of constructing, operating, maintaining, and removing a total of 2,547' of above-ground waterline and one (1) air release valve on State Game Land No. 302 in West Finley Township, Washington County (Exhibit RED 14). The waterline will be placed in an existing 50' wide natural gas pipeline right-of-way licensed to CNX earlier this year, and CNX will use the same licensed temporary workspace and access road for construction, operation, maintenance and removal of this waterline. The waterline will be used to transport reuse water during completion and flowback of natural gas wells, while reducing truck traffic around SGL 302. The SUP includes conditions to minimize the potential for pollution and impacts to sportsmen and wildlife on the game lands.

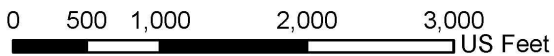

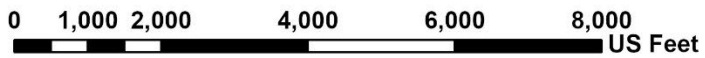
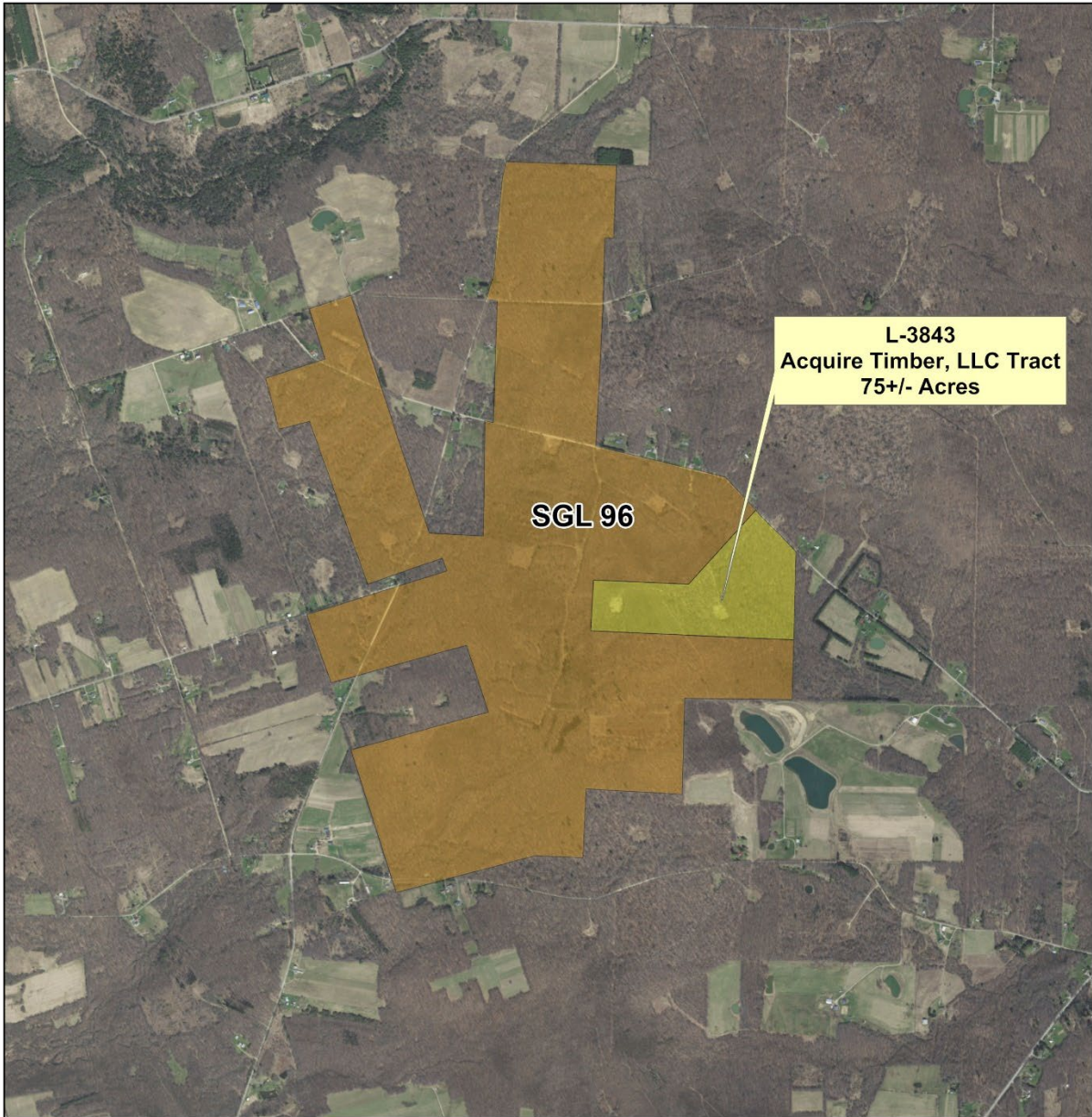
