- 1 PRESIDENT BOOP: Good morning. I'd like to call to
- 2 order the formal business meeting of our April meeting.
- 3 With respect to the sidebar here, probably many of you noticed
- 4 Commissioner Isabella was not with us yesterday. It's a very
- 5 serious health issue involving his wife. He spent the day at
- 6 the hospital yesterday and he is going to be joining us by phone
- 7 today. We're hoping that that's going to work satisfactorily
- 8 and not create a distraction for us.
- 9 Again, I'd like to formally welcome all of you to our business
- 10 meeting of our two-day Commission meeting. If you'll now join
- 11 us in the Pledge of Allegiance to the flag.
- 12 (Pledge of Allegiance said.)
- 13 PRESIDENT BOOP: In Commissioner Isabella's physical
- 14 absence, I asked Commissioner Palone, our vice president, to
- 15 assist us with the duties that normally would be performed by
- 16 the secretary. So, Vice President Palone, would you please call
- 17 roll?
- 18 MRS. PALONE: President Boop?
- 19 PRESIDENT BOOP: Here.
- 20 MRS. PALONE: Vice President Palone, here.
- 21 MRS. PALONE: Secretary Isabella?
- MR. ISABELLA: Present.
- 23 MRS. PALONE: Commissioner Schleiden.

- 1 MR. SCHLEIDEN: Present.
- 2 MRS. PALONE: Commissioner Riley?
- 3 MR. RILEY: Present.
- 4 MRS. PALONE: Commissioner Mohr.
- 5 MR. MOHR: Here.
- 6 MRS. PALONE: Commissioner Hill.
- 7 MR. HILL: Here.
- 8 MRS. PALONE: Commissioner Schreffler.
- 9 MR. SCHREFFLER: Present.
- 10 MRS. PALONE: All present and accounted for.
- 11 PRESIDENT BOOP: Thank you, Commissioner Palone.
- 12 Our minutes of our January 23, 2006 meeting are here today for
- 13 approval. Do I hear a motion that they be approved?
- MR. RILEY: So moved.
- 15 PRESIDENT BOOP: Is there a second?
- MR. SCHREFFLER: Second.
- 17 PRESIDENT BOOP: All in favor.
- 18 (Signified aye.)
- 19 MRS. PALONE: Unanimous, Mr. President.
- 20 PRESIDENT BOOP: The minutes are approved.
- 21 As far as our agenda for today, the preprinted agenda
- 22 is available. I assume that those of you who are interested
- 23 have received copies. I believe there are more up front or
- 24 available if you don't have one. What we're going to do is

- 1 we're going to follow the agenda as it's printed. We'll go to
- 2 the first item, which is generally the seasons and bag limits
- 3 agenda item.
- 4 We like to do this on a page by page basis, so, Mr.
- 5 Pouss, if you could start with this and we'll go to the first
- 6 page, which is page 3 for our first action item?
- 7 MR. POUSS: Thank you, Mr. President.
- 8 The first item relates to adoption of proposed
- 9 amendment to §139.4, Title 58 of the Pennsylvania Code.
- To effectively manage the wildlife resources of this
- 11 Commonwealth, the Game Commission, at its October 4, 2005
- 12 meeting, proposed the following change:
- To amend §139.4 (relating to seasons and bag limits
- 14 for the license year) to provide updated seasons and bag limits
- 15 for the 2006-2007 hunting license year.
- 16 This proposed amendment was published on January 7,
- 17 2006, in the Pennsylvania Bulletin.
- The Executive Director and staff recommend final
- 19 adoption of this amendment to 58 Pa. Code as shown on Exhibit A.
- Do you want me to read it?
- 21 PRESIDENT BOOP: Page 3, Exhibit A is before us. I
- 22 don't know if you actually need to read it. I would like to
- vote each page, because I'm assuming we may have some
- 24 amendments.

- 1 MR. SCHLEIDEN: Mr. President, we can vote to approve,
- 2 make a motion and a second and then we can make amendments if
- 3 you want to.
- 4 PRESIDENT BOOP: Do you want to do it that way?
- 5 MR. SCHLEIDEN: I recommend that we do it that way.
- 6 It will probably save some time.
- 7 PRESIDENT BOOP: Is the Board in agreement?
- 8 (Indicates yes.)
- 9 PRESIDENT BOOP: Do I hear such a motion?
- 10 MR. SCHLEIDEN: So moved.
- 11 PRESIDENT BOOP: Is there a second?
- MR. RILEY: Second.
- PRESIDENT BOOP: Discussion?
- MR. ISABELLA: Mr. President, I backed out a little
- 15 bit there. What exactly are we doing right now?
- 16 PRESIDENT BOOP: We're going to proceed generally to
- 17 approve the seasons and bag limits and then we're going to
- 18 consider amendments by page, as I understand it from
- 19 Commissioner Schleiden's position.
- MR. ISABELLA: Okay, that's all.
- 21 PRESIDENT BOOP: We have a motion. I have a second.
- 22 All in favor? Is there any additional discussion?
- MRS. PALONE: For the present page.

- 1 PRESIDENT BOOP: Each page, page 3. Any discussion
- 2 with respect to page 3?
- 3 (No response.)
- 4 PRESIDENT BOOP: Hearing none, page 4?
- 5 (No response.)
- 6 PRESIDENT BOOP: Hearing none, page 5?
- 7 (No response.)
- PRESIDENT BOOP: Hearing none, page 6?
- 9 (No response.)
- 10 MR. SCHREFFLER: Yes.
- 11 PRESIDENT BOOP: Commissioner Schreffler.
- 12 MR. SCHREFFLER: There was a date there, January 12.
- 13 It was changed to the thirteenth.
- 14 PRESIDENT BOOP: The last item on page 6 I think we
- 15 discovered that the date of January 12 is a Friday, and January
- 16 13, 2007. We wanted to change that.
- MR. SCHREFFLER: Yes, I do. Make sure that's January
- 18 13.
- MR. SCHLEIDEN: I'll second that motion, sir.
- 20 PRESIDENT BOOP: Any further discussion on that item?
- 21 (No response.)
- 22 PRESIDENT BOOP: All in favor of that page?
- 23 (Signified aye.)
- 24 PRESIDENT BOOP: Opposed?

- 1 (No response.)
- 2 MRS. PALONE: Unanimous, Mr. President.
- PRESIDENT BOOP: Page 7, any discussion on page 7?
- 4 (No response.)
- 5 PRESIDENT BOOP: I would like to offer an amendment
- 6 with respect to page 7, having to do with the length of the
- 7 concurrent deer season and propose here for a 12-day concurrent
- 8 season statewide, which is what we heard yesterday afternoon.
- 9 It's the recommendation from the Deer Management Team.
- 10 I think we all agree that what we heard yesterday was
- 11 the science portion. We do have a three-legged stool, which
- 12 includes political, social and science. In light of what I have
- 13 heard as a Commissioner for the past year, I'm not really
- 14 comfortable sitting on this one-legged stool of science only.
- 15 For one, I'm not completely convinced that all our problems
- 16 before us are as simple as saying it's just the deer.
- 17 I would like to offer an amendment on page 7 to be
- 18 concurrent buck/doe season would be in Management Units 2B, 5C
- 19 and 5D as stated, which are the special reg Management Units
- 20 generally. And the other 19 Management Units I would move for
- 21 an amendment to a concurrent season of one week, which would be
- 22 from December 4 through December 9, in the other 19 Management
- 23 Units would be my motion to amend.
- MR. SCHLEIDEN: I'll second that.

- 1 PRESIDENT BOOP: Discussion?
- 2 MRS. PALONE: Mr. President, I just would like to say
- 3 that yesterday we had several people testify, I think around 50,
- 4 if I'm not mistaken. A lot of those folks were hunters and a
- 5 lot of them came from other walks of life. We had business
- 6 people. We had different producers, people who do landscaping,
- 7 agriculture, forestry.
- I believe that we did listen to a lot of social issues
- 9 yesterday. I don't believe that social is just hunters, but
- 10 it's also people who have deer conflicts either in their
- 11 businesses, or on the highways or in agriculture.
- 12 So I do really feel that the Commission has taken into
- 13 consideration all the social issues having to do with deer. I
- 14 feel like we've done that in a very responsible way. So when I
- 15 think of social, I think of more than just hunters and a lot of
- 16 these people who testified yesterday are also hunters, so they
- 17 wear more than one hat. So I feel like the social issues have
- 18 been addressed by the Commission.
- 19 PRESIDENT BOOP: Any discussion?
- MR. SCHLEIDEN: Call for the question.
- 21 PRESIDENT BOOP: Question has been called for.
- We're voting on the amendment that was offered on page
- 23 7, which would be to in effect reduce the concurrent season in
- 24 19 of the 22 Management Units from the 12-day to a 6-day season.

- 1 All in favor?
- MR. RILEY: Mr. President, I ask that we vote on a
- 3 show of hands.
- 4 PRESIDENT BOOP: All in favor of the motion to amend?
- 5 MRS. PALONE: Two.
- 6 (Commissioners Mohr and Boop raised hands.)
- 7 PRESIDENT BOOP: Opposed?
- 8 MRS. PALONE: Six opposed.
- 9 (Commissioners Palone, Schreffler, Isabella,
- 10 Schleiden, Riley and Hill oppose.)
- 11 PRESIDENT BOOP: So the motion to amend fails.
- 12 I would like to offer a second amendment on page 7,
- 13 and the second amendment would be to reduce the concurrent
- 14 season in Management Units 3A, 3C and 2F to a six-day concurrent
- 15 season, which would begin on Monday, December 4 and end on
- 16 Saturday, December 9.
- 17 And in Management Units 2C, 2G, 4B a three-day
- 18 concurrent season, which would begin on Thursday, December 14
- 19 and end on Saturday, December 16 -- excuse me, that's incorrect.
- 20 Seventh and the ninth. Begin on December 7 and end on December
- 21 9, the last three days concurrent to the season with the
- 22 authority for the Executive Director to extend for three
- 23 additional days in those three Management Units in the event of
- 24 inclement weather.

- 1 These are the six Management Units where the bulk of
- 2 the complaints seem to come from concerning the present Deer
- 3 Management Plan.
- 4 It's this Commissioner's considered opinion, given the
- 5 allocation numbers and been recommended by the team that the six
- 6 and the three-day season in those six Management Units will
- 7 accomplish our objectives.
- That's my amendment, second amendment.
- 9 MR. MOHR: Second.
- 10 PRESIDENT BOOP: Discussion?
- MR. ISABELLA: Mr. President, I just want to make sure
- 12 this is an amendment that is reducing the season days in certain
- 13 WMUs?
- 14 PRESIDENT BOOP: Correct.
- MR. ISABELLA: Okay, thank you.
- 16 PRESIDENT BOOP: Discussion?
- 17 (No response.)
- PRESIDENT BOOP: Can we have a show of hands again?
- 19 We're voting on the second amendment. All in favor?
- 20 MRS. PALONE: Two, Mr. President, in favor.
- 21 (Commissioners Mohr and Boop raise hands.)
- 22 PRESIDENT BOOP: Opposed?
- MRS. PALONE: Six opposed, Mr. President.

- 1 (Commissioners Palone, Schreffler, Isabella,
- 2 Schleiden, Riley and Hill oppose.)
- 3 PRESIDENT BOOP: Motion fails.
- 4 Any other amendments with respect to page 7?
- 5 (No response.)
- 6 PRESIDENT BOOP: Page 8. We have a handout with
- 7 respect to that page relating to the bear season.
- 8 MR. RILEY: Mr. President, bear, any ages, strike the
- 9 Wildlife Management Units 3B, 3C, and 3D, 4C and 4E and add the
- 10 following language: "Wildlife Management Units 3C, 3D and that
- 11 portion of 3B, east of Route 14 from Troy to Canton, east of
- 12 Route 154 from Canton to Route 220 at Laporte and east of Route
- 13 42 from Laporte to Route 118 and that portion of 4E east of
- 14 Route 42."
- 15 Additional language, Mr. President, "Portion of
- 16 Wildlife Management Units 2G and 3B in Lycoming County that lie
- 17 north of the west branch of the Susquehanna River from the Route
- 18 405 bridge, west to the Route 220 bridge, east of Route 220 to
- 19 Route 44 and east of Route 44 to Route 973, south of Route 973
- 20 to Route 87, west of Route 87 to Route 864, south of Route 864
- 21 to Route 220 and west of Route 220 to Route 405 and west of
- 22 Route 405 to the west branch of the Susquehanna River."
- MR. SCHREFFLER: I'll second that.

- 1 PRESIDENT BOOP: Commissioner Riley's amendment is
- 2 seconded by Commissioner Schreffler, as it's printed on the blue
- 3 handout that we have received and discussed yesterday.
- Is there discussion on the amendment?
- 5 (No response.)
- 6 PRESIDENT BOOP: Hearing no discussion, all those in
- 7 favor of the amendment say aye.
- 8 (Signified aye.)
- 9 PRESIDENT BOOP: Opposed?
- 10 (No response.)
- 11 MRS. PALONE: It's unanimous, Mr. President.
- 12 PRESIDENT BOOP: Thank you, Commissioner Palone.
- Page 9, any discussion or amendment with respect to
- 14 page 9?
- 15 (No response.)
- 16 PRESIDENT BOOP: Hearing none, with respect to page
- 17 10, which is just the notations with respect to seasons and bag
- 18 limits, any discussion or comments concerning those?
- 19 (No response.)
- 20 PRESIDENT BOOP: If not, we voted on the seasons and
- 21 bag limits with the amendment on page 6, with respect to the
- 22 change of date from January 12 to January 13, and the change
- 23 with respect to deer season that's set forth on page 8. These
- 24 amendments are adopted as stated with those two amendments.

- 1 MR. SCHLEIDEN: We have to vote.
- 2 PRESIDENT BOOP: Call for a vote. All
- 3 in favor?
- 4 (Signified aye.)
- 5 PRESIDENT BOOP: Opposed?
- 6 (Signified no.)
- 7 MRS. PALONE: Could we ask for a roll call vote or
- 8 not?
- 9 PRESIDENT BOOP: Sure.
- 10 MRS. PALONE: We're going to have a roll call vote,
- 11 Greg.
- President Boop?
- 13 PRESIDENT BOOP: No.
- MRS. PALONE: Vice President Palone, yes.
- 15 Secretary Isabella?
- MR. ISABELLA: Aye.
- 17 MRS. PALONE: Commissioner Schleiden?
- MR. SCHLEIDEN: Aye.
- 19 MRS. PALONE: Commissioner Riley?
- MR. RILEY: Yes.
- 21 MRS. PALONE: Commissioner Mohr?
- MR. MOHR: No.
- 23 MRS. PALONE: Commissioner Hill?
- MR. HILL: Yes.

- 1 MRS. PALONE: Commissioner Schreffler?
- 2 MR. SCHREFFLER: Yes.
- MRS. PALONE: It is six in favor and two opposed.
- 4 PRESIDENT BOOP: Thank you, Vice President.
- We'll now go to page 11 of our agenda.
- 6 MR. POUSS: Thank you, Mr. President.
- 7 The next item relates to adoption of proposed
- 8 amendments to §§147.552-147.554 of Title 58 of the Pennsylvania
- 9 Code.
- To effectively manage the wildlife resources of this
- 11 Commonwealth, the Game Commission, at its January 24, 2006
- 12 meeting, proposed the following changes:
- 13 Amend the sections as previously stated (relating to
- 14 application, permit and subpermit) to modify the public access,
- 15 signage posting and subpermit issuance requirements for
- 16 Agricultural Deer Control Permit permittees in Wildlife
- 17 Management Units 5C and 5D.
- 18 These proposed amendments were published in the
- 19 Pennsylvania Bulletin on March 25, 2006.
- 20 The Executive Director and staff recommend final
- 21 adoption of these amendments to 58 Pa. Code as shown on Exhibit
- 22 B, which is on page 12 of your agenda.
- PRESIDENT BOOP: The action as printed on page 12. Do
- 24 we have a motion with respect to this agenda item?

- 1 MR. SCHREFFLER: So moved.
- 2 PRESIDENT BOOP: Do we have a second?
- 3 MR. SCHREFFLER: I'll second it.
- 4 PRESIDENT BOOP: Commissioner Schreffler.
- 5 Do we have discussion?
- 6 (No response.)
- 7 PRESIDENT BOOP: Any discussion on the item?
- 8 (No response.)
- 9 PRESIDENT BOOP: If not, all those in favor?
- 10 (Signified aye.)
- 11 PRESIDENT BOOP: Opposed?
- 12 (No response.)
- 13 MRS. PALONE: Unanimous, Mr. President.
- 14 PRESIDENT BOOP: The Chair would like to make a
- 15 notation, a thanks to Commissioner Isabella for all his work in
- 16 resolving what was a difficult issue in these two Management
- 17 Units for the Commission.
- 18 Commissioner Isabella, I'd like to publicly thank you
- 19 for that.
- MR. ISABELLA: Thank you, Mr. President.
- 21 PRESIDENT BOOP: Mr. Pouss.
- MR. POUSS: The next item on the agenda is on page 13
- 23 and relates to adoption of proposed amendment to §141.18 of
- 24 Title 58 of the Pennsylvania Code.

- 1 The Game Commission, at it's January 24, 2006 meeting,
- 2 proposed the following change relating to permitted devices.
- Amend §141.18 to specifically permit the use of
- 4 electronic devices used for locating dogs while hunting or
- 5 training, including such devices as e-collars, radio-telemetry
- 6 dog tracking systems and beeper collars.
- 7 The proposed amendment was published in the
- 8 Pennsylvania Bulletin on March 25, 2006.
- 9 The Executive Director and staff recommend final
- 10 approval of this amendment to 58 Pa. Code as shown on Exhibit C,
- 11 which is page 14 in your agenda.
- 12 PRESIDENT BOOP: You've heard the reading concerning
- 13 the action item as printed on page 14; is there a motion to
- 14 approve?
- MR. RILEY: So moved.
- 16 PRESIDENT BOOP: Mr. Riley.
- 17 Is there a second?
- MR. MOHR: Second.
- 19 PRESIDENT BOOP: Commissioner Mohr.
- Is there discussion on the item?
- 21 (No response.)
- 22 PRESIDENT BOOP: Hearing none, all those in favor.
- 23 (Signified aye.)
- 24 PRESIDENT BOOP: Opposed?

- 1 (No response.)
- 2 MRS. PALONE: It's unanimous, Mr. President.
- PRESIDENT BOOP: Thank you, Mrs. Palone.
- 4 Mr. Pouss.
- 5 MR. POUSS: Mr. President, the next item on the agenda
- 6 is on page 15. It relates to adoption of proposed amendments to
- 7 §§131.2 and 141.41 of Title 58.
- 8 To effectively manage the wildlife resources of this
- 9 Commonwealth, the Game Commission, at its January 24, 2006
- 10 meeting, proposed the following changes:
- Amend §§131.2 and 141.41 (relating to definitions and
- 12 general) to define and implement the use of the atlatl and dart
- 13 during any firearms deer season.
- 14 These proposed amendments were published in the
- 15 Pennsylvania Bulletin on April 1, 2006.
- 16 The Executive Director and staff do not recommend
- 17 final adoption of these amendments to 58 Pa. Code, as shown on
- 18 Exhibit D, which is on page 16 of your agenda.
- 19 PRESIDENT BOOP: You heard the reading. The item
- appears on page 16.
- 21 Do I hear a motion?
- MR. RILEY: So moved.
- MR. HILL: Mr. President?

- 1 PRESIDENT BOOP: I think we heard two. We heard Mr.
- 2 Hill. Commissioner Hill?
- 3 MR. HILL: Mr. President, I'd like to make a motion
- 4 that we refer this item back to committee.
- 5 PRESIDENT BOOP: Is there a second?
- 6 MR. SCHLEIDEN: Second.
- 7 PRESIDENT BOOP: The motion on the floor is to refer
- 8 this action item back to committee, made by Commissioner Hill
- 9 and seconded by Commissioner Schleiden.
- 10 Discussion on the motion?
- MR. RILEY: On that, Mr. President, this issue appears
- 12 that we're not basing this decision on science. It's totally a
- 13 political and social decision, so I sure hope that the
- 14 Commissioners take that same stance when we get to antlerless
- 15 allocations.
- 16 PRESIDENT BOOP: Any other discussion on the item?
- 17 Yes, Commissioner Palone.
- 18 MRS. PALONE: Mr. President, is this Law Enforcement
- 19 Committee? Is that where we want this to be?
- 20 PRESIDENT BOOP: I think that would be appropriate.
- 21 Do you accept that as an amendment, Mr. Hill?
- MR. HILL: (Indicates yes.)
- 23 PRESIDENT BOOP: Commissioner Schleiden?
- MR. SCHLEIDEN: Yes, sir.

- 1 PRESIDENT BOOP: Referral to the Law Enforcement
- 2 Committee.
- 3 MR. SCHLEIDEN: Mr. President.
- 4 PRESIDENT BOOP: Yes, Commissioner Schleiden.
- 5 MR. SCHLEIDEN: Commissioner Mohr, I don't believe
- 6 there's any science to present it to the Board on this
- 7 particular issue. However, there was a demonstration. So the
- 8 only thing we had to view was the social and political;
- 9 therefore, we are looking at that issue from that standpoint.
- Those people who advocate the use of this now have
- 11 time, because we put it into committee, now have time to bring
- 12 their case forward, and if it requires science, they'll have
- 13 that opportunity. I don't think it has anything to do with
- 14 allocations.
- Thank you, sir.
- 16 PRESIDENT BOOP: Other discussion?
- 17 MR. ISABELLA: Mr. President.
- 18 PRESIDENT BOOP: Yes, Commissioner Isabella.
- MR. ISABELLA: I just want to make sure I know exactly
- 20 what's happening. We're referring the atlatl, the issue of the
- 21 atlatl to a Law Enforcement Committee?
- 22 PRESIDENT BOOP: Back to the Law Enforcement
- 23 Committee, yes.
- MR. ISABELLA: Okay, thank you.

- 1 PRESIDENT BOOP: Other discussion?
- 2 (No response.)
- 3 PRESIDENT BOOP: Vote. All in favor of the motion to
- 4 send the atlatl back to the Law Enforcement Committee for study
- 5 indicate by saying aye.
- 6 (Signified aye.)
- 7 PRESIDENT BOOP: Opposed?
- 8 (Commissioner Palone indicated nay.)
- 9 MRS. PALONE: Seven to one.
- 10 PRESIDENT BOOP: Thank you, Commissioner Palone.
- Mr. Pouss.
- 12 MR. POUSS: The next item on the agenda is proposed
- 13 rule making on page 17. It's to amend 58 Pa. Code, Chapter 141,
- 14 by adding Subchapter M, §§143.241-143.247.
- Due to today's complex society, family structure
- 16 changes and the competing interests youths have to choose from,
- 17 it is difficult for our sporting men and women to introduce
- 18 youngsters to the joys of hunting. On December 22, 2005,
- 19 Governor Rendell signed into law House Bill 1690 to provide a
- 20 way to better combat these challenges.
- In effect, this statutory amendment authorized the
- 22 Pennsylvania Game Commission to create, define and implement a
- 23 concept aptly named the "Mentored Youth Hunting Program".

- 1 The mission of the Mentored Youth Hunting Program is
- 2 simple and clear: create, expanded youth hunting opportunities
- 3 while maintaining safety afield. The MYHP provides youngsters a
- 4 chance to develop the love of hunting early and allow that
- 5 passion to grow as they do. The MYHP promotes the culture and
- 6 development of the type of one-on-one training, and hands on
- 7 experience that will help protect our hunting future as well as
- 8 increase hunting safety through the intimate counseling provided
- 9 by dedicated Mentors.
- 10 Youths who might otherwise never experience hunting
- 11 will now have the chance to taste the thrills and past
- 12 generations as they carry this Commonwealth's hunting heritage
- 13 into the future. The MYHP may not benefit all youths; however,
- 14 it does provide a vehicle into the hunting fraternity for many
- 15 youngsters whose parents feel are mentally, emotionally and
- 16 physically ready for the rigors of hunting.
- 17 It was only with the dedicated assistance of various
- 18 sportsmen's organizations that MYHP was even possible. Indeed,
- 19 the MYHP concept was initially developed and promoted by the
- 20 determination of organizations such as the National Wild Turkey
- 21 Federation, Pennsylvania Federation of Sportsmen's Clubs, United
- 22 Bowhunters of Pennsylvania, Central Counties Concerned
- 23 Sportsmen, National Rifle Association, Quality Deer Management

- 1 Association, Rocky Mountain Elk Foundation, Big Brothers/Big
- 2 Sisters Pass It On Program and U.S. Sportsmen's Alliance.
- In a world in which everyone seems to have less and
- 4 less time, and we never seem to place the proper value on the
- 5 truly important things, there can be no greater way to instill
- 6 values, provide the ideal time and place to teach conservation,
- 7 respect, ethics and responsibilities that we all have as
- 8 caretakers of our streams and forests, than by adopting the MYHP
- 9 in Pennsylvania.
- 10 You can see the text on the youth provisions on pages
- 11 18, 19 and 20 of the agenda.
- 12 The recommendation is by the Executive Director and
- 13 staff that the Commission approve this new subchapter.
- PRESIDENT BOOP: You've heard the reading by Mr.
- 15 Pouss. The action item does appear on pages 18, 19, and 20.
- 16 Is there a motion?
- 17 MR. SCHLEIDEN: So moved.
- 18 PRESIDENT BOOP: Commissioner Schleiden.
- 19 Is there a second?
- MR. MOHR: Second.
- 21 PRESIDENT BOOP: Commissioner Riley.
- Is there discussion?
- MRS. PALONE: Mr. President.
- 24 PRESIDENT BOOP: Yes, Mrs. Palone.

- 1 MRS. PALONE: I would just like to offer an amendment.
- 2 On page 19, on §143.243, subsection (b) where we talk about the
- 3 species that the youth are allowed to hunt, we had a lot of
- 4 discussion about this and we wanted to include deer, some of us
- 5 did. We feel that deer is important.
- 6 But in talking to all the folk within the agency that
- 7 would have implemented this program, we felt that there was some
- 8 administrative issues that would need to be worked out and we
- 9 would need a little better tracking system. We feel like we
- 10 didn't have enough time to take all of this into consideration
- 11 for the fall season.
- 12 We feel that on July 1, of 2007, we would have a point
- 13 of sale system in place and we can track better who would be
- 14 mentors and who would be youths. So we decided that we would
- 15 put deer off until next year.
- 16 So I just want to offer this amendment under (b) and
- 17 it would read: "A mentored youth's hunting eligibility is
- 18 restricted to the following species: squirrel, woodchuck and
- 19 wild turkey (spring gobbler season only) for 2006 and 2007, and
- 20 antlered year starting with the 2007 and 2008 season mentored
- 21 youths would have to comply with the same antlered requirements
- 22 as junior licensed holders.
- PRESIDENT BOOP: Before we go further, I just would
- 24 like to note on the record one item, Commissioner Palone. With

- 1 respect to your comment, you said "decided." We had discussions
- 2 concerning this item. There was no decision. I just want to
- 3 make it clear.
- 4 MRS. PALONE: Yes, pardon me.
- 5 PRESIDENT BOOP: No vote was taken and no decision was
- 6 made during our work session.
- 7 Yes, is there further discussion on this item?
- 8 MR. SCHREFFLER: Mr. President.
- 9 PRESIDENT BOOP: Yes, Commissioner Schreffler.
- 10 MR. SCHREFFLER: I want to agree that I think that
- 11 this makes sense that we not include deer this year, to make it
- 12 an issue for next year for the very same reasons that Mrs.
- 13 Palone had expressed. I think it will work out much easier for
- 14 us all, especially, I think this first year it's better to start
- 15 simple and work the program and see how it works and do a plan
- 16 committee and approve it next year.
- I just wanted to make that point.
- 18 PRESIDENT BOOP: I assume that's your second,
- 19 Commissioner?
- MR. SCHREFFLER: That's my second, yes.
- 21 PRESIDENT BOOP: Is there any other discussion?
- 22 MR. MOHR: On that, Mr. President, on that matter I
- 23 think the more we try to restrict this youth hunting opportunity
- 24 the probably less receptive it's going to be. I assumed all

- 1 along that we would just allow those youths to participate in
- 2 any season, the only stipulation being that they had to be in a
- 3 stationary position when they were participating.
- 4 So I'm sort of disappointed that we're even
- 5 restricting it to the species we are and deer, definitely deer
- 6 or what anyone wants to go after. Relating to deer, I think
- 7 we're only restricting ourselves to how many people are going to
- 8 participate. I'd surely like to see it open for all species and
- 9 just add the stationary position being the only mandatory
- 10 requirement.
- 11 End of my comments.
- PRESIDENT BOOP: Other comments?
- 13 MR. RILEY: Mr. President, Commissioner Mohr's
- 14 comments are well-taken, I think, but when we look at this whole
- 15 youth hunting area and this mentored youth, there are a lot of
- 16 things to consider. I think it's best that we go a little
- 17 slower. During work session several problems arose in terms of
- 18 regulations and how we get them in place. Safety is a major
- 19 consideration here.
- So we want to get this mentored youth hunt going. We
- 21 want to include those species, especially the antlered deer. We
- 22 will do so as quickly as we can put regulations in place so that
- 23 we know that safety is the primary goal of this delay.
- Thank you.

- 1 PRESIDENT BOOP: Any other comment?
- 2 (No response.)
- 3 PRESIDENT BOOP: So we're voting on the item--
- 4 MR. ISABELLA: Excuse me, Mr. President.
- 5 PRESIDENT BOOP: Yes.
- 6 MR. ISABELLA: Are we still in discussion?
- 7 PRESIDENT BOOP: We're in discussion.
- 8 MR. ISABELLA: I originally when we discussed this
- 9 last meeting, as you remember, I really wanted to include other
- 10 species, like doves. I received numerous e-mails from people
- 11 who wanted to include deer hunting for this year. After
- 12 realizing how popular that was, I was ready to support that
- 13 amendment to include deer.
- But, also, we have to be certain that the mechanics
- 15 that we're using is correct. We have to get it correct the
- 16 first time in how we're -- we know how many mentors are involved
- 17 and how many youths are involved. We just have to get it right
- 18 and going slow is the correct way.
- I also received e-mails in reference to pheasant
- 20 hunting. Unfortunately, when you're trying to do the right
- 21 thing there are people who are trying to twist around what we're
- 22 doing and say that we want to eliminate pheasant hunting
- 23 altogether. That definitely isn't true.

- 1 Those people are dealing in fantasy land. I want to
- 2 deal and the rest of our Board, I know we're dealing with facts.
- 3 So we need to go at this slow.
- 4 Although I said I wanted the vote to include deer for
- 5 this year, I agree with what was said by our staff. We have to
- 6 go slow, so I will support this amendment for deer for next year
- 7 and hopefully, we're going to include other species.
- 8 That's it. Thank you.
- 9 PRESIDENT BOOP: Thank you, Commissioner Isabella, for
- 10 your always colorful commentary.
- Is there any other discussion?
- MR. SCHLEIDEN: Mr. President, there's one other
- 13 factor that weigh heavily on my decision to support until next
- 14 year, along with some of the staff comments was the fact that
- 15 the programs that we have in place for our Deer Team right now,
- 16 they, in fact, really need to take a look at what is going on in
- 17 the surrounding states and see how that would affect the
- 18 program, the recommendations they have made thus far in
- 19 anticipating this for next year if, in fact, we made a vote to
- 20 the anterless issue between now and then.
- 21 So I think this gives them time to put it into the
- 22 proper prospective so that we can vote on it from the science
- 23 aspect as well.
- 24 Thank you, sir.

- 1 PRESIDENT BOOP: Any other Commissioner have comments?
- 2 (No response.)
- 3 PRESIDENT BOOP: If not, as I understand the item on
- 4 the floor is we have the agenda item. We have Commissioner
- 5 Palone's amendment, which would include deer as a covered
- 6 species in the 2007/2008 year. You will be voting on her
- 7 amendment, as seconded by Commissioner Schreffler. So we're
- 8 voting on the amendment, which would include deer in 2007/2008.
- 9 Is that your understanding, Commissioner Palone?
- 10 MRS. PALONE: Antlered deer and they would have to
- 11 comply with the antler restrictions that junior license holders
- 12 would have to comply with.
- 13 PRESIDENT BOOP: Acceptable, Commissioner Schreffler,
- 14 as amendment?
- MR. SCHREFFLER: Absolutely.
- 16 PRESIDENT BOOP: Does everyone understand what we're
- 17 voting on?
- 18 MR. RILEY: What was the comment on antler
- 19 restriction?
- 20 PRESIDENT BOOP: Commissioner Palone, do you want to
- 21 restate that, please?
- 22 MRS. PALONE: These mentored youths would have to
- 23 comply with the same requirements as junior license holders in
- 24 regard to antler restrictions.

- 1 PRESIDENT BOOP: Everyone understands what we're
- 2 voting on? We're voting on the amendment as authored by
- 3 Commissioner Palone.
- 4 All those in favor say aye.
- 5 (Signified aye.)
- 6 PRESIDENT BOOP: Opposed?
- 7 (No response.)
- 8 MRS. PALONE: Unanimous, Mr. President.
- 9 PRESIDENT BOOP: We will vote now on the main motion.
- 10 So we're voting on this agenda item as now amended.
- 11 All in favor, signify by aye.
- 12 (Signified aye.)
- PRESIDENT BOOP: Opposed?
- 14 (No response.)
- MRS. PALONE: Unanimous, Mr. President.
- 16 PRESIDENT BOOP: Thank you.
- Mr. Pouss.
- MR. POUSS: Mr. President, the next on the agenda is
- 19 on page 21 and involves the amendment of §131.6 of Pa. Code.
- On September 30, 2003, Pennsylvania's Driving Under
- 21 the Influence statutes were substantially modified and relocated
- 22 from 75 Pa. Consolidated Statue, §3731 to 75 Pa. Consolidated
- 23 Statue, §3801 et seq. Despite staff's awareness of the
- 24 amendment, 58 Pa. Code 131.6 was never formally amended to

- 1 reflect the changes to the DUI statutes. In an effort to
- 2 finally correct the inaccurate reference and citation in 58 Pa.
- 3 Code 131.6 to the proper, current DUI provisions, staff
- 4 recommends the following minor housekeeping amendment. This
- 5 amendment does not expand Wildlife Conservation Officer
- 6 enforcement authority relating to police powers.
- 7 You can see the text on page 21. The recommendation
- 8 by the Executive Director and staff is that the Commission
- 9 approve this change. I believe this is proposed for amendment.
- 10 PRESIDENT BOOP: You've heard the reading by counsel
- 11 on the action item.
- 12 Do I hear a motion?
- MR. RILEY: So moved.
- 14 PRESIDENT BOOP: Mr. Riley.
- 15 Is there a second?
- MR. SCHLEIDEN: Second.
- 17 PRESIDENT BOOP: Mr. Schleiden.
- 18 Discussion?
- 19 (No response.)
- 20 PRESIDENT BOOP: Hearing none, I guess we're ready for
- 21 vote.
- 22 All in favor say aye.
- 23 (Signified aye.)
- 24 PRESIDENT BOOP: Opposed?

- 1 (No response.)
- 2 MRS. PALONE: It's unanimous, Mr. President.
- 3 PRESIDENT BOOP: Thank you, Commissioner Palone.
- 4 Mr. Pouss.
- 5 MR. POUSS: Mr. President, the next item is on page 22
- 6 of the agenda and it involves amending 58 Pa. Code, §135.107.
- 7 Since September goose hunting was initiated, the
- 8 resident Canada goose population on and in the vicinity of the
- 9 Middle Creek Wildlife Management Area has declined dramatically.
- 10 As added evidence of the population decline, hunter success
- 11 rates in the controlled area at Middle Creek have dropped from
- 12 57 percent in 1996 to 16 percent in 2005.
- The Commission staff believes that it is absolutely
- 14 necessary to reduce the harvest of resident geese at the Middle
- 15 Creek Wildlife Management Area to sustain and recover Canada
- 16 goose population in the area and preserve the quality of the
- 17 waterfowl hunting experience in the controlled management area.
- 18 An interdisciplinary group has met and recommended
- 19 several administrative and regulatory changes to reduce goose
- 20 harvests and improve hunting on the controlled area at Middle
- 21 Creek. Enhanced hunter education and changes in the management
- 22 of hunting blinds on the area will be part of the changes
- 23 implemented for the 2006 season. Also recommended was a
- 24 reduction from four to three days in the number of waterfowl

- 1 shooting days at Middle Creek, eliminating Mondays. This can be
- 2 accomplished by amending 58 Pa. Code, §137.107(a)(4) as outlined
- 3 below.
- 4 The text is on page 22. The recommendation by the
- 5 Executive Director and staff is that the Commission approve this
- 6 change.
- 7 PRESIDENT BOOP: You've heard the reading with respect
- 8 to this proposed agenda item as set forth at the bottom of page
- 9 22. Is there a motion?
- MR. SCHLEIDEN: So moved.
- 11 PRESIDENT BOOP: Commissioner Schleiden.
- 12 Is there a second?
- MR. SCHREFFLER: Second.
- 14 PRESIDENT BOOP: Mr. Schreffler.
- 15 Discussion on the item?
- MR. MOHR: Comment, Mr. President.
- 17 PRESIDENT BOOP: Yes, sir.
- MR. MOHR: The declining goose population in Middle
- 19 Creek I think there's far more factors involved there than just
- 20 hunting.
- 21 I would like to ask staff as part of this if they
- 22 will, in fact, do a review of the management practices that are
- 23 going on in Middle Creek to make sure that everything is being

- 1 done to, in fact, maintain a viable population, in fact, to
- 2 increase the population of the goose.
- 3 PRESIDENT BOOP: Any other comment?
- 4 (No response.)
- 5 PRESIDENT BOOP: Hearing none, all in favor of the
- 6 item indicate by saying aye.
- 7 (Signified aye.)
- 8 PRESIDENT BOOP: Opposed?
- 9 (No response.)
- 10 MRS. PALONE: It's unanimous, Mr. President.
- 11 PRESIDENT BOOP: Mr. Pouss.
- MR. POUSS: The next item on the agenda is on page 23
- 13 and relates to amending 58 Pa. Code, §141.4.
- 14 The proposal is to amend this section to reflect the
- 15 annual change in days and subsequent shooting times. This also
- 16 reflects the new daylight savings time, which starts on March
- 17 11, 2007.
- You can see the text of the change on pages 23 and 24.
- 19 The recommendation by the Executive Director and staff
- 20 is the Commission approve this change.
- 21 PRESIDENT BOOP: As we look at the item as printed on
- 22 page 24, I just would call attention to the fact that daylight
- 23 savings time is significantly different in 2007. It's moved up

- 1 almost a month and that's reflected in the chart, for those of
- 2 you who are looking at it.
- 3 With respect to this action item, do we hear a motion?
- 4 MR. RILEY: So moved.
- 5 PRESIDENT BOOP: Second?
- 6 MR. SCHREFFLER: Second.
- 7 PRESIDENT BOOP: Discussion?
- 8 (No response.)
- 9 PRESIDENT BOOP: All in favor.
- 10 (Signified aye.)
- PRESIDENT BOOP: Opposed?
- 12 (No response.)
- 13 MRS. PALONE: It's unanimous, Mr. President.
- 14 PRESIDENT BOOP: Thank you.
- Mr. Pouss.
- 16 MR. POUSS: Mr. Pouss, the next item is on page 25 of
- 17 the agenda and relates to hunting license revocations,
- 18 convictions. Proposed recommendations to revoke the hunting and
- 19 furtaking privileges of the individuals convicted of violating
- 20 the Game and Wildlife Code.
- The Commission, under the authority of the Game and
- 22 Wildlife Code, may revoke any hunting license and furtaker's
- 23 license and deny any person the right to secure a license or to
- 24 hunt and furtake anywhere in the Commonwealth, with or without a

- 1 license, if said licensee or person has been convicted, or
- 2 signed an acknowledgment of violating any provision of the Game
- 3 and Wildlife Code. The Commission may revoke such licenses for
- 4 a period not to exceed three years for the first offense; for a
- 5 second or subsequent offense, for such period of time as the
- 6 Commission shall determine.
- 7 Persons denied the right to hunt or furtake in the
- 8 Commonwealth are notified by Certified Mail that the revocation
- 9 will commence July 1, 2006, and continue for such period as set
- 10 forth following the individual's name. The symbol "RA" means
- 11 the revocation was added to an existing revocation.
- 12 In accordance with the Administrative Agency Law, the
- 13 person placed on revocation has the opportunity for an
- 14 Administrative Hearing. If an Administrative Hearing is
- 15 requested, a petition for review must be filed at the Commission
- 16 Headquarters within 30 days from the date of the notice.
- 17 Unless deemed in the best interest of the Commission
- 18 by the Director or a designee, hearings shall be conducted at
- 19 the central office. Hearings will be conducted in accordance
- 20 with the General Rules of Administrative Practice and Procedure.
- 21 The hearing itself will be conducted in accordance with Chapter
- 22 35 of the rules and Chapter 145 of Title 58 of Pa. Code.
- The Executive Director and the Law Enforcement
- 24 Director recommend that the Commission revoke the hunting and

- 1 furtaking license privileges of the persons named by the Bureau
- 2 of Law Enforcement. Such revocation shall become effective July
- 3 1, 2006, and shall continue for such period of time and under
- 4 the conditions set forth following each individual's name.
- 5 PRESIDENT BOOP: I believe that all of the
- 6 Commissioners received a list of the individuals so affected by
- 7 this agenda item.
- 8 Do we hear a motion?
- 9 MR. RILEY: So moved.
- 10 PRESIDENT BOOP: Mr. Riley.
- 11 A second?
- 12 MRS. PALONE: Second.
- 13 PRESIDENT BOOP: Commissioner Palone.
- 14 Any discussion?
- MR. MOHR: Comment, Mr. President. I'm looking here
- 16 at my list. I think here again we have several hundred names on
- 17 a list that we're automatically taking out of our customer base.
- 18 At a time when their money is out-sourced, I think maybe we
- 19 should reevaluate what offenses we give a revocation and what
- 20 offenses we just accept a fine and turn them loose. Do it
- 21 again, they collect a fine again next year.
- 22 So I would ask that the Executive Director see fit, as
- 23 he sees fit that he would, in fact, review these revocations,
- 24 not each particular ones, but a list of offenses that fall under

- 1 Board revocation and a committee, or he sees fit that a change
- 2 has been made, so not so many are on the revocation list and we
- 3 can continue to receive the revenue.
- 4 PRESIDENT BOOP: It's one of concerns we don't want to
- 5 become more like PENNDOT. Comment is well taken. I'm sure the
- 6 Executive Director is duly noted.
- 7 Is there any other discussion?
- 8 (No response.)
- 9 PRESIDENT BOOP: All those in favor say aye.
- 10 (Signified aye.)
- 11 PRESIDENT BOOP: Opposed?
- 12 (No response.)
- 13 MRS. PALONE: It's unanimous, Mr. President.
- 14 PRESIDENT BOOP: I'd like to thank Mr. Houghton for
- 15 representing the Bureau of Law Enforcement this morning. Thank
- 16 you, Greg.
- 17 MR. HOUGHTON: You're welcome.
- 18 PRESIDENT BOOP: At this point I think we're going to
- 19 take a recess. The Bureau of Land Management will be next. We
- 20 have a number of items that are in the agenda. I am not
- 21 anticipating that the handling of these items is going to take
- 22 very long. Once they're completed, we'll take up the issue of
- 23 the antlerless allocations under new business.

- 1 So at this point we're going to recess for a half-an-
- 2 hour.
- 3 (Recess 9:30 A.M.)
- 4 (Reconvened 9:55 A.M.)
- 5 PRESIDENT BOOP: When we adjourned for recess there
- 6 was a question asked me by one of the reporters in the audience
- 7 whether or not we were taking an executive session. We were not
- 8 taking an executive session. We planned a break midway through
- 9 the morning.
- 10 At the end of the day yesterday a number of the
- 11 Commissioners had asked for some additional information on
- 12 allocation numbers, which was given this morning to the
- 13 Commissioners, some additional information. They reviewed it
- 14 individually, but there was no executive session. That will
- 15 clear the record on that.
- 16 Also, it was brought to our attention that Bureau of
- 17 Law Enforcement also had an additional item which needs to be
- 18 included at today's hearing. This is a supplement. I believe
- 19 all the Commissioners have a copy at their places. This
- 20 concerns the Administrative Hearings.
- 21 Mr. Houghton has a handout covers that item.
- MR. HOUGHTON: Yes. Yes, I do.
- PRESIDENT BOOP: You would want this handled through
- 24 your Bureau?

- 1 MR. HOUGHTON: Correct.
- 2 PRESIDENT BOOP: Bill, if you could handle the reading
- 3 of that item without the names?
- 4 MR. POUSS: Okay, Mr. President.
- 5 The first item is labeled (A) I guess, Administrative
- 6 Hearings.
- 7 Administrative Hearings are held to review the Hunting
- 8 and Furtaking Revocations for those persons who file a petition
- 9 requesting a review, in accordance with Administrative Agency
- 10 Law.
- 11 The Commission was furnished a copy of the Findings of
- 12 Fact, the Conclusions of Law, and the Recommendations of the
- 13 Hearing Officer concerning the Administrative Hearing held at
- 14 the request of each individual listed below. The Findings of
- 15 Fact set forth the circumstances surrounding this matter.
- 16 The Executive Director recommends that the Commission
- 17 approve the Findings of Fact, Conclusions of Law, and
- 18 Recommendation of the Hearing Officer, Andrew Lehman, allowing
- 19 the revocation period to remain as originally ordered for each
- 20 individual listed and there are six names listed.
- 21 PRESIDENT BOOP: You heard the reading of this item.
- 22 You got a copy in front of you. Do we hear a motion?
- MR. RILEY: So moved.
- 24 PRESIDENT BOOP: Mr. Riley.

- 1 Do we hear a second?
- 2 MR. SCHLEIDEN: Second.
- 3 PRESIDENT BOOP: Commissioner Schleiden.
- 4 Discussion?
- 5 (No response.)
- 6 PRESIDENT BOOP: All in favor indicate saying aye.
- 7 (Signified aye.)
- 8 PRESIDENT BOOP: Opposed?
- 9 (No response.)
- 10 MRS. PALONE: It's unanimous, Mr. President.
- MR. POUSS: Okay, the next item is labeled (B) and
- 12 also involves Administrative Hearings concerning reducing the
- 13 hunting and furtaking revocation.
- 14 It was indicated Administrative Hearings are held to
- 15 review Hunting and Furtaking Revocation under the Administrative
- 16 Agency Law.
- 17 The Commission was furnished a copy of the Findings of
- 18 Fact, Conclusions of Law, and Recommendations of the Hearing
- 19 Officer concerning the Administrative Hearing held at the
- 20 request of each individual listed.
- 21 The recommendation is that the Executive Director
- 22 recommends that the Commission approve the Findings of Fact,
- 23 Conclusions of Law, and Recommendation of the Hearing Officer,

- 1 Andrew Lehman, allowing the revocation period to be reduced for
- 2 each individual listed. There are two individuals listed.
- 3 PRESIDENT BOOP: You heard the presentation on this
- 4 action item which is (B) under the Law Enforcement Bureau. Is
- 5 there a motion?
- 6 MR. SCHLEIDEN: So moved.
- 7 PRESIDENT BOOP: Mr. Schleiden.
- 8 Is there a second?
- 9 MR. RILEY: Second.
- 10 PRESIDENT BOOP: Mr. Riley.
- 11 Is there discussion?
- 12 (No response.)
- 13 PRESIDENT BOOP: All in favor consent by saying aye.
- 14 (Signified aye.)
- PRESIDENT BOOP: Opposed same sign.
- 16 (No response.)
- 17 MRS. PALONE: It's unanimous, Mr. President.
- PRESIDENT BOOP: Part C, Mr. Pouss.
- 19 MR. POUSS: Again, relates to Administrative Hearings
- 20 that are held to review Hunting and Furtaking Revocations under
- 21 the Administrative Agency Law.
- The Commissions was furnished copies of Findings of
- 23 Fact, Conclusions of Law, and Recommendations of the Hearing

- 1 Officer. The Findings of Fact set forth the circumstances
- 2 surrounding this matter.
- 3 The Executive Director recommends that the Commission
- 4 approve the Findings of Fact, Conclusions of Law and
- 5 Recommendation of the Hearing Officer, Andrew Lehman, allowing
- 6 the revocation period to be rescinded, resulting in no
- 7 revocation for the one individual listed.
- 8 PRESIDENT BOOP: You heard the reading. Is there a
- 9 motion?
- 10 MR. RILEY: So moved.
- 11 PRESIDENT BOOP: Mr. Riley.
- 12 Is there a second?
- MR. SCHLEIDEN: Second.
- 14 PRESIDENT BOOP: Mr. Schleiden.
- 15 Is there discussion?
- 16 (No response.)
- 17 PRESIDENT BOOP: If not, all in favor indicate by
- 18 saying aye.
- 19 (Signified aye.)
- 20 PRESIDENT BOOP: Opposed same sign?
- 21 (No response.)
- 22 MRS. PALONE: It's unanimous, Mr. President.
- PRESIDENT BOOP: Thank you, Mr. Houghton.

- 1 We'll now move to the Bureau of Land Management. I
- 2 recognize Bureau Director Klinger at the podium.
- I refer to Mr. Pouss for the first item.
- 4 MR. POUSS: The first item is on page 26 of the agenda
- 5 and relates to two acquisitions of land.
- 6 The first one relates to Option No. 4069 48 acres
- 7 more or less of land in Albany Township, Berks County, adjoining
- 8 State Game Lands No. 106, as shown on Exhibit LM1, which is page
- 9 27 of your agenda. The option is subject to a timber
- 10 reservation with regard to an ongoing timber operation pursuant
- 11 to a plan worked out with the Southeast Regional Forester. The
- 12 option price is \$48,000 lump sum to be paid from monies escrowed
- 13 from a coal lease to Landnar, Inc., on State Game Lands No. 264.
- 14 Should I do the other option now?
- 15 PRESIDENT BOOP: Please.
- 16 MR. POUSS: The other option is No. 4070 and relates
- 17 to 221 acres more or less of coal and minerals in Monroe
- 18 Township, Bradford County, underlying State Game Lands No. 36,
- 19 as shown on Exhibit LM2, which is page 28 of your agenda. The
- 20 option prices is \$3,400 lump sum.
- The Executive Director and staff recommend the options
- 22 listed above be accepted and the Commission authorize the Bureau
- 23 of Land Management to proceed with the acquisition of these
- 24 tracts.

- 1 PRESIDENT BOOP: The two acquisitions as set forth and
- 2 the option number as noted. They're depicted on pages 27 and 28
- 3 of the agenda.
- 4 Do we hear a motion to approve?
- 5 MR. SCHREFFLER: So moved.
- 6 PRESIDENT BOOP: Commissioner Schreffler.
- 7 Is there a second?
- 8 MR. MOHR: Second.
- 9 PRESIDENT BOOP: Commissioner Mohr.
- 10 Is there any discussion?
- 11 Commissioner Schreffler.
- 12 MR. SCHREFFLER: I think both these are excellent
- 13 decisions by our staff. I really encourage everybody to go
- 14 along with this. I command the staff for doing a good job in
- 15 this.
- 16 PRESIDENT BOOP: The Chair will concur with those
- 17 thoughts.
- 18 Are there other comments?
- 19 (No response.)
- 20 PRESIDENT BOOP: I hear a motion to approve both
- 21 acquisitions. We're voting on the motion.
- 22 All in favor say aye.
- 23 (Signified aye.)
- 24 PRESIDENT BOOP: Opposed same sign.

- 1 (No response.)
- 2 MRS. PALONE: Unanimous, Mr. President.
- PRESIDENT BOOP: Mr. Pouss, page 29.
- 4 MR. POUSS: Yes, Mr. President.
- 5 That item relates to land exchange involving State
- 6 Game Lands No. 79, in Jackson Township, Cambria County.
- Jackson Township Water Authority has agreed to a land
- 8 exchange involving a right-of-way 3,000 feet long and 30 feet
- 9 wide across a portion of State Game Lands No. 79 in Jackson
- 10 Township, Cambria County, as shown on Exhibit LM3, which is page
- 11 30 of your agenda.
- In exchange, Jackson Township Water Authority will
- 13 cause to be conveyed a tract of land totaling three acres, more
- 14 or less, in Jackson Township, Cambria County, also shown on
- 15 Exhibit LM3. This exchange straightens the boundary line.
- 16 The staff has reviewed this proposal and has
- 17 determined it to be of equal or greater value for the benefit of
- 18 wildlife.
- The Executive Director and staff recommend this land
- 20 exchange be approved and the Commission authorize the Bureau of
- 21 Land Management to proceed with the exchange as listed above.
- 22 PRESIDENT BOOP: You've heard the reading with respect
- 23 to this agenda item, the exhibit which appears on page 30 of the
- 24 preprinted agenda. Do I hear a motion to approve?

- 1 MR. SCHLEIDEN: So moved.
- 2 PRESIDENT BOOP: Commissioner Schleiden.
- Is there a second?
- 4 MR. SCHREFFLER: Second.
- 5 PRESIDENT BOOP: Commissioner Schreffler.
- 6 Is there discussion or comment?
- 7 (No response.)
- 8 PRESIDENT BOOP: If not, all those in favor consent by
- 9 saying aye.
- 10 (Signified aye.)
- 11 PRESIDENT BOOP: Opposed same sign.
- 12 (No response.)
- 13 MRS. PALONE: Unanimous, Mr. President.
- PRESIDENT BOOP: Mr. Pouss.
- 15 MR. POUSS: I think the final item on the agenda is
- 16 relating to Land Management. It's an oil and gas lease
- 17 amendment. It involves surface mining coal, also. It involves
- 18 State Game Lands No. 75, in Pine Township, Lycoming County.
- 19 Fisher Mining Company of Montoursville, PA, seeks to
- amend its existing 159 acre lease (Tract 075A-04) by adding 27.3
- 21 acres of additional mining area to the lease, as shown on
- 22 Exhibit OGM1, which is on page 33 of the agenda.
- The proposed amendment will allow Fisher Mining
- 24 Company to remove an additional estimated total of 249,858 tons

- 1 of coal from the leased premises. This amendment, if approved,
- 2 will allow Fisher Mining Company to remove coal from two
- 3 separate areas that are adjacent to the existing mining areas of
- 4 Fisher's leases.
- 5 The proposed amended mining area consist of a 14-acre
- 6 area and a 13.3-acre area. The 13.3-acre area is currently
- 7 under Fisher Mining's existing lease and is designated as mining
- 8 support area. The 140acre area includes approximately 2.5 acres
- 9 currently under lease and an additional 11.5 acres of new lease
- 10 area.
- 11 No additional acreage will be required for support
- 12 areas under this proposals. All proposed mining areas have
- 13 already been reviewed and approved in accordance with the
- 14 Pennsylvania Department of Environmental Protection's surface
- 15 mining regulations.
- 16 As part of the mine reclamation plan, Fisher Mining
- 17 will complete a stream enhancement project on the Right Fork of
- 18 Otter Run and construct wetland complexes in order to enhance
- 19 existing terrestrial and aquatic wildlife habitats. The mining
- 20 and reclamation plan will consist of leaving a coal barrier in
- 21 place, adding a minimum of 1,200 tons per acre of alkaline
- 22 addition material on the pit floor, and constructing an
- 23 infiltration basin to release alkaline water into an acid
- 24 impaired receiving stream. The project is directed towards

- 1 increasing the overall alkalinity of the Right Fork of Otter Run
- 2 to induce natural trout reproduction.
- 3 The accumulated coal royalty value of the proposed
- 4 additional mining has been estimated to be \$763,216 which will
- 5 be paid in full to the Commission upon the final execution of
- 6 the lease amendment. All coal royalty payments being paid
- 7 directly into the Commission's Game Fund. All merchantable
- 8 timber which is cut, and/or impacted by this mining operation
- 9 will be assessed by the Commission's Northcentral Regional
- 10 forestry staff, and payments owed to the Commission will be made
- 11 in strict accordance with that existing terms and conditions of
- 12 the original lease. All other terms of the current lease will
- 13 remain unchanged.
- Mining will be regulated by the Commonwealth's Surface
- 15 Mining Regulations and the Commission's existing mining lease
- 16 agreement.
- 17 The staff has reviewed this proposal and determined
- 18 the stream enhancement, in conjunction with the advanced coal
- 19 royalty schedule and timber value, to be equal to or greater
- 20 than the total accumulated coal lease value.
- 21 The Executive Director and staff recommend this Coal
- 22 Mining lease amendment be approved and the Commission authorize
- 23 the Bureau of Land Management to proceed with the leasing
- 24 arrangement as listed above.

- 1 PRESIDENT BOOP: You've heard the description of the
- 2 agenda item, which is depicted on the exhibit, which appears as
- 3 page 33 for the surface mining coal lease amendment.
- 4 Do I hear a motion to approve?
- 5 MR. HILL: So moved.
- 6 PRESIDENT BOOP: Commissioner Hill.
- 7 Is there a second?
- 8 MR. RILEY: Second.
- 9 PRESIDENT BOOP: Commissioner Riley.
- 10 Is there discussion or comment?
- 11 (No response.)
- 12 PRESIDENT BOOP: Hearing none, all in favor of this
- 13 surface mining coal lease amendment as stated indicate by saying
- 14 aye.
- 15 (Signified aye.)
- 16 PRESIDENT BOOP: Opposed same sign.
- 17 (No response.)
- 18 MRS. PALONE: Unanimous, Mr. President.
- 19 PRESIDENT BOOP: Thank you, Mr. Klinger.
- We are now at the point in the agenda where we conduct
- 21 new business. Under new business we will take up the antlerless
- 22 allocations for the 22 Management Units.

- 1 Mr. DuBrock and Dr. Rosenberry are both present. The
- 2 Commissioners all have the 22 handouts with respect to the
- 3 antlerless allocations as presented here yesterday afternoon.
- 4 I believe that the suggestion has been that we handle
- 5 these in much the same manner as we handle seasons and bag
- 6 limits. We would vote preliminarily and then go through them
- 7 individually and then take a final vote.
- 8 Is that agreeable to all Commissioners?
- 9 MRS. PALONE: I just wanted to ask, Mr. President, if
- 10 we could have a show of hands and that it would be easier for me
- 11 to count?
- 12 PRESIDENT BOOP: I'd be happy to do that.
- So initially I guess we would ask for a motion to
- 14 approve the allocations as presented yesterday afternoon,
- 15 preliminary approval for the 22 Management Units for the
- 16 allocation figures that are set forth.
- MR. SCHREFFLER: So moved, Mr. President.
- 18 PRESIDENT BOOP: Commissioner Schreffler.
- 19 Is there a second?
- MR. SCHLEIDEN: Second.
- 21 PRESIDENT BOOP: Commissioner Schleiden.
- Now, we're going to have discussion on each individual
- 23 Management Unit. So I guess we'll start with 1A.

- 1 Chris, it might be helpful if you would share the
- 2 podium with Cal. So we're talking 1A where the recommended
- 3 allocation for 2006-2007 is 42,000 allocations.
- 4 Is there discussion on the allocation recommendation
- 5 for this Management Unit?
- 6 MR. MOHR: Discussion, Mr. President. In fact, I'd
- 7 like to make an amendment to that. In 1A, the chart we received
- 8 it says "deer health, satisfactory; habitat, satisfactory;
- 9 conflicts, low; and population trend is stable." In an area
- 10 like that it seems to me that it's a prime candidate, prime
- 11 example for actually starting to increase the deer herd to
- 12 satisfy some of our other stakeholders.
- 13 So in 1A I'd like to amend the motion that we have and
- 14 make a motion that we, in fact, we allow the population to
- 15 increase somewhat and that we reduce that allocation from 42,000
- 16 to 36,000 and continue with a 12-day season.
- 17 PRESIDENT BOOP: Is there a second to that amendment?
- I will second the amendment.
- 19 Is there discussion on the amendment?
- MR. ISABELLA: Yes, Mr. President.
- 21 PRESIDENT BOOP: Yes, Commissioner Isabella.
- MR. ISABELLA: I just want to make sure I understand
- 23 exactly. Is there an amendment, proposed amendment for WMU 1A

- 1 to reduce the recommended allocation to 36,000; is that what I'm
- 2 hearing right?
- 3 PRESIDENT BOOP: That's correct.
- 4 MR. ISABELLA: Okay, thank you.
- 5 PRESIDENT BOOP: Is there other comment or discussion
- 6 on the amendment?
- 7 MRS. PALONE: Mr. President.
- PRESIDENT BOOP: Yes, Commissioner Palone.
- 9 MRS. PALONE: Yesterday we heard a lot of testimony
- 10 from different people on deer-human conflicts. Even though the
- 11 biologists have done a very good job in working with measures,
- 12 we did hear yesterday that the measures were a work in progress.
- 13 We don't have them all of them in place yet.
- I feel that the deer-human conflicts measures are our
- 15 weak link right now in my evaluation of these antlerless
- 16 allocations. Just as an example, if we look at Wildlife
- 17 Management Unit 2B, that's where Pittsburgh is located, the
- 18 deer-human conflicts on our assessment was minimal, because only
- 19 two deer were harvested in DMAP. But we know that the deer-
- 20 human conflicts around Pittsburgh are not minimal.
- 21 So I guess I couldn't with a clear conscience vote yet
- 22 to increase some of these deer populations and change the
- 23 objective, because I don't feel like we have a good handle on
- 24 our deer-human conflicts. We heard yesterday there were a lot

- 1 of discussion about forest regeneration and we know it takes
- 2 more than one year for forests to be regenerated.
- We also know that Pennsylvania led the United States
- 4 in lyme disease in 2003. We were 27 percent of all the cases in
- 5 the United States. Pennsylvania vehicle collisions with deer
- 6 are about, they average 12 deaths per year. This is an enormous
- 7 cost to our society.
- 8 The landscaping industry is between five and eight
- 9 million dollars annually. Agriculture costs average \$9,000 per
- 10 farm. So there are a lot of conflicts out there. I feel that
- 11 we need a little more data on those.
- 12 Also, we worry about deer diseases, chronic waste
- 13 disease is on both sides of us, and tuberculosis. Even though I
- 14 don't feel that chronic waste disease would wipe out the deer
- 15 herd, I believe that in high populations that diseases spread a
- 16 lot faster, and deer is a very social animal. We have a lot of
- 17 roads, a lot of ways for diseases to spread in Pennsylvania, a
- 18 lot of people.
- So I just feel that we should not be increasing the
- 20 herd in some of these Wildlife Management areas until we have a
- 21 little bit more, a better handle on this deer-human conflicts.
- 22 PRESIDENT BOOP: Are there other comments or
- 23 discussion?

- 1 MR. MOHR: Mr. President, I would like to add to that
- 2 that when the Deer Team presented the figures to us they did
- 3 mention emphatically this is a science. Now it's up to you to
- 4 add the social and political. They tell you about a three-
- 5 legged stool. We surely shouldn't base and try to sit on just
- 6 that one leg of science. We have other decisions here today
- 7 based on social and political. I'm sure they've been warned
- 8 that the deer population trend and the objective be scrutinized
- 9 by political and social issues also.
- 10 Cal or Chris, would you like to comment on that
- 11 amendment that I made? In fact, I encourage you to.
- 12 MR. DUBROCK: We're just looking to see who drew the
- 13 short straw.
- I think this is a scenario again where we've discussed
- 15 with the Wildlife Management Committee and individually with
- 16 Commissioners from time to time. We collect the biological
- 17 information, interpret it. You certainly have the
- 18 responsibility of setting policy and setting direction.
- 19 So in particular we're talking about 1A. This
- 20 Management Unit, again the characteristics of it are that deer
- 21 health is satisfactory. In fact, the younger age classes
- 22 reproduction is good. Habitat health again is satisfactory,
- 23 conflicts low. Population in the last two years has been

- 1 relatively stable. Over the longer term, five-year has
- 2 declined.
- 3 This is a scenario not too dissimilar from discussion
- 4 we had about area 4B where we had the Citizen Advisory
- 5 Committee. This is a population that we probably could
- 6 increase. We would want to proceed cautiously and monitor the
- 7 impacts on deer health and habitat health.
- 8 So if that is the wish of the Board to allow a slight
- 9 increase and begin to move this population in the other
- 10 direction, we would not be opposed to that direction.
- 11 PRESIDENT BOOP: I would like to also offer a little
- 12 comment. The Board has already on a six to two vote decided to
- 13 continue the 12-day concurrent season, which is very unpopular
- 14 with many of our hunters. Our written comments that we receive
- 15 that come into the staff in terms of supporting the current deer
- 16 program one to six, reduce anterless allocations 460.
- 17 Those of us who are out there and are hunters and
- 18 interact with the stakeholders, our legislators have told us, in
- 19 fact, they have pleaded with us to offer them some options. We
- 20 didn't offer them options with the current seasons. This is the
- 21 chance to offer some options. We got the science to support us
- 22 here. This Management Unit will support a slight increase.
- Commissioner Mohr's amendment is a modest reduction.
- 24 We're still going to have 12-day season in 1A. We're talking

- 1 about a reduction in allocation from 42 to 36. It's my
- 2 understanding it's about four licenses to kill a deer.
- 3 MR. ROSENBERRY: In this Unit 3.
- 4 PRESIDENT BOOP: In this Unit 3, so you can do the
- 5 math.
- 6 I think that we need to send some direction here
- 7 somewhere. We don't have too many opportunities left to send
- 8 that direction. Sixty thousand hunters did not buy a license in
- 9 Pennsylvania last year and there's a reason for that. We can
- 10 debate the reasons here all day, but if there's anyone that
- 11 feels broad satisfaction with this program, go around and say.
- 12 MR. DUBROCK: Mr. President, if I may add one
- 13 additional comment, which I neglected to add?
- 14 PRESIDENT BOOP: Yes.
- MR. DUBROCK: I'd just like to point out one other
- 16 thing and that is the land use within this particular Management
- 17 Unit. This is kind of throwing you a little curve, but
- 18 something you need to think about as well. About half of this
- 19 particular Management Unit is forested, but two out of every
- 20 five acres is also involved in agriculture.
- 21 So increases certainly will be felt in that community
- 22 more so than in the forest health community. So that's
- 23 something to factor into your deliberation, but recognizing that
- 24 particular aspect of this Management Unit.

- 1 PRESIDENT BOOP: Any other comment or discussion?
- 2 MR. SCHLEIDEN: Mr. President.
- 3 PRESIDENT BOOP: Yes, Mr. Schleiden.
- 4 MR. SCHLEIDEN: I'm just looking at the annual, going
- 5 back to 2003, the allocation was 44,000. Our people felt we
- 6 needed to increase that. We moved it up in 2004 to 48,000. Two
- 7 thousand five they took another look at it and dropped it to 40.
- 8 Obviously, looking at it, they felt that they needed to increase
- 9 it somewhat and recommended it to 42.
- So you're really dropping in two-year fact from 48 to
- 11 36, which is a significant drop while we're trying to collect
- 12 data. I do know that there's a lot of agriculture out in that
- 13 area trying to get it from a deer license.
- 14 That's my comment. Thank you.
- PRESIDENT BOOP: Again, you know how I feel that
- 16 there's a risk. When we have all the data collected the door
- 17 may be closed.
- 18 Is there any other discussion?
- MR. MOHR: One more comment, Mr. President.
- 20 With those lands that are in private ownership we do
- 21 have programs now that allow those individual landowners to help
- 22 take care of their own situation. DMAP is surely available in
- 23 all of them.

- 1 PRESIDENT BOOP: If there's no further discussion
- 2 we're voting on the amendment in Management Unit 1A to lower the
- 3 allocation from 42,000 to 36,000. May I see a show of hands of
- 4 those that support that amendment?
- 5 (Hands raised.)
- 6 MRS. PALONE: Two, Mr. President.
- 7 PRESIDENT BOOP: Those opposed?
- 8 MRS. PALONE: Greg, are you for or against the
- 9 amendment?
- 10 MR. ISABELLA: I'm against it.
- 11 MRS. PALONE: Okay, six nos.
- 12 PRESIDENT BOOP: All right, if there are no other
- 13 amendments with respect to 1A, we'll move to 1B.
- 14 Is there any discussion on 1B?
- MR. ISABELLA: What's the next one you want me to be
- 16 looking at now?
- 17 PRESIDENT BOOP: One (B), yeah, like in Bob.
- 18 MR. ISABELLA: Oh, 1B, okay. I got it.
- 19 PRESIDENT BOOP: No discussion or comment on 1B?
- 20 (No response.)
- 21 PRESIDENT BOOP: We'll move to 2A.
- 22 MRS. PALONE: Mr. Boop, do we have to vote on each one
- 23 individually?

- 1 PRESIDENT BOOP: I think we're going to vote at the
- 2 end if there are no amendments to save some time.
- 3 So I take it there's no comment or discussion on 1B.
- 4 The allocation recommendation there is 30,000.
- 5 Moving to 2A, comment or discussion in 2A where the
- 6 recommended allocation is 55,000?
- 7 MR. MOHR: Two (A), Mr. President, is another WMU
- 8 that, in fact, the deer health is satisfactory; habitat
- 9 satisfactory; deer-human conflict is minimal, but that's
- 10 Commissioner Palone's area and she still feels there's far too
- 11 many deer out there, so my advice would be to hire some buses
- 12 and get some Amish out there.
- 13 PRESIDENT BOOP: Any other comment or discussion on 2A
- 14 where the allocation recommendation is 55,000?
- 15 (No response.)
- 16 PRESIDENT BOOP: Moving to 2B, recommended allocation
- 17 is 58,000 in 2B.
- 18 Comment or discussion?
- 19 MRS. PALONE: Mr. President, I just want reiterate
- 20 this is the area I was referring to that has Pittsburgh in it.
- 21 The deer-human conflicts were reported as low. We know that's
- 22 not the case, so I know we'll be working on this measure in the
- 23 future. But the other thing that we considered was we kept the
- 24 allocation the same as last year, because that's about all that

- 1 we can sell. So there's really not much use in having lots of
- 2 allocations where people aren't going to buy them if the market
- 3 is saturated.
- 4 PRESIDENT BOOP: Any other comment on 2B? The
- 5 recommended allocation is 58,000.
- 6 (No response.)
- 7 PRESIDENT BOOP: Going to 2C, recommendation
- 8 allocation is 49,000.
- 9 Comment/discussion?
- 10 MR. SCHREFFLER: Mr. President, I'd like to make a
- 11 comment.
- In 2C, there is some concern by some of the landowners
- 13 about the lack of deer, but we see poor health and poor habitat
- 14 health in that area. I'd like to comment that in 2004, we had
- 15 75,000 allocations, which dropped in 2005, to 53. This year
- 16 we're dropping it to 49,000. I'd just like to make that
- 17 comment.
- I have no question about I think that is a reasonable
- 19 move for this Wildlife Management Unit.
- 20 PRESIDENT BOOP: Anyone else have a comment at all on
- 21 2C?
- 22 (No response.)
- PRESIDENT BOOP: Moving to 2D, the recommended
- 24 allocation is 56,000.

- 1 MR. MOHR: Mr. President, I'd like to offer an
- 2 amendment on 2D, much like I did on 1A. Two (D) shows good deer
- 3 health; satisfactory habitat, minimal deer-human conflicts.
- 4 There again, I'd like to submit that we reduce that allocation
- 5 to 51,000 from the recommended allocation of 56,000.
- 6 PRESIDENT BOOP: Is there a second to Mr. Mohr's
- 7 proffered amendment to reduce the allocation in 2D from 56,000
- 8 to 51,000?
- 9 I will second the amendment.
- 10 Is there any additional discussion or is there
- 11 discussion on the amendment?
- 12 Yes, Mr. Schreffler?
- MR. SCHREFFLER: I have a question for the deer
- 14 people.
- 15 What is the land use characteristics in this area?
- 16 MR. ROSENBERRY: In 2D, about 68 percent forested and
- 17 27 percent ag and fields.
- PRESIDENT BOOP: Other questions or comments?
- MR. SCHREFFLER: That's it.
- 20 PRESIDENT BOOP: Hearing none, we're voting on
- 21 Commissioner Mohr's amendment to reduce the allocation in 2D for
- 22 2006/2007 from 56,000 to 51,000.
- Show of hands, all those in favor of the amendment?
- (Commissioners Boop and Mohr raise hands.)

- 1 MRS. PALONE: Two in favor.
- 2 PRESIDENT BOOP: Opposed?
- 3 (Commissioners Schreffler, Isabella, Riley, Palone,
- 4 Schleiden and Hill oppose.)
- 5 MRS. PALONE: Six opposed.
- 6 PRESIDENT BOOP: The amendment fails.
- 7 Any further amendment with respect to 2D? If not,
- 8 we'll move to 2E.
- 9 (No response.)
- 10 PRESIDENT BOOP: Two (E) the recommendation allocation
- 11 there is 21,000.
- 12 Any comment, discussion with respect to 2E?
- 13 (No response.)
- 14 PRESIDENT BOOP: Hearing none, we'll go to 2F. Two
- 15 (F) the recommended allocation is 28,000.
- 16 Comment or discussion with respect to 2F?
- 17 (No response.)
- 18 PRESIDENT BOOP: Hearing none, we'll move to 2G. Two
- 19 (G) the recommended allocation 19,000.
- 20 Comment or discussion?
- 21 MR. MOHR: Mr. President, 2G is a prime example of a
- 22 WMU that is far too large as far as I'm concerned. I think Cal
- 23 has stated that 75 percent of it's private, 25 percent is state

- 1 owned, but what's the percent of forested to all the land in
- 2 that WMU?
- 3 MR. ROSENBERRY: In Wildlife Management Unit 2G it's
- 4 90 percent forested, but 49 percent public.
- 5 MRS. PALONE: Forty-nine percent what?
- 6 MR. ROSENBERRY: Public lands.
- 7 MR. MOHR: Also, I think that's a good example there
- 8 that deer probably aren't the problem. By continuing to reduce
- 9 or keep that deer level down I will see very little change in
- 10 the habitat. I would contend in that area DCNR and the private
- 11 forestry practices are more the blame for it than the deer.
- 12 It does show a reduction, but even reducing that
- 13 allocation to 19,000, it's still only going to, at best,
- 14 stabilize a herd that's depleted in an area that we get an awful
- 15 lot of public comment.
- 16 PRESIDENT BOOP: This is an area where we're looking
- 17 at the future for pilots. I believe that we could select an
- 18 area in 2G and we could kill all the deer and there would be
- 19 little or no regeneration in most of those areas.
- 20 Any other comment?
- MR. MOHR: That's it.
- MR. SCHLEIDEN: I've been to 2G quite a bit and it's
- 23 strange. Do you fence it is growing? There will be fences. We
- 24 had 2G in 2003, was 52,000 allocation. In 2004, 52,000

- 1 allocation; 2005, 29; 2006, right now is down to 19. I think
- 2 that if you want to say that people are looking at both the
- 3 social and political, I would say that that indicates and the
- 4 habitat is still poor in my estimation. We do have a problem up
- 5 there.
- It's not one in which we are not looking at. I know
- 7 that our people up there in Land Management have, in fact, tried
- 8 some lining in certain areas and we're looking at that. So
- 9 right now the reason it's poor is because we got the land with
- 10 our piece both for 75 years.
- I'm really not happy with that allocation. I would
- 12 like to see it higher, but I'm willing to live with it.
- PRESIDENT BOOP: Other comments?
- MR. MOHR: The bottom line on that allocation is that
- 15 we're stabilized. Even though it's more than 19,000, we reduced
- 16 to 19,000, it's not allowing that herd to increase. There's a
- 17 prime example where maybe a WMU you should have a different
- 18 antlerless allocation for public and private lands.
- 19 Some folks think that political and social issues will
- 20 have no bearing. Probably this is the reason.
- 21 PRESIDENT BOOP: Any other comments or discussions?
- (No response.)
- PRESIDENT BOOP: Moving to 3A, recommended allocation
- 24 in 3A is 29,000.

- 1 Comment or discussion with respect to the recommended
- 2 allocation in 3A for 2006/2007?
- 3 (No response.)
- 4 PRESIDENT BOOP: Hearing none, we move to 3B. Three
- 5 (B) the recommended is 43,000 for '06/07.
- Is there comment or discussion with respect to this
- 7 recommended allocation?
- 8 (No response.)
- 9 PRESIDENT BOOP: Hearing none, we'll move to 3C.
- 10 Three (C) the recommended allocation is 27,000.
- 11 No comment or discussion with respect to 3C.
- 12 (No response.)
- PRESIDENT BOOP: We move to 3D. Three (D) the
- 14 recommended allocation is 38,000.
- 15 Comment or discussion pertaining to that WMU's
- 16 allocation recommendation?
- 17 (No response.)
- 18 PRESIDENT BOOP: Hearing none, we'll move to 4A.
- 19 Recommended allocation there is 29,000.
- 20 Comment or discussion with respect to this WMU?
- MR. MOHR: Four (A), Mr. President, I'd like to make
- 22 an amendment there also. Deer health, habitat, conflicts
- 23 they're all showing a sign that good, satisfactory, low. I'd

- 1 like to make an amendment there to reduce that allocation to
- 2 22,000.
- 3 PRESIDENT BOOP: Is there a second to Commissioner
- 4 Mohr's amendment?
- I will second the amendment.
- Is there discussion or comment on the amendment?
- 7 (No response.)
- 8 PRESIDENT BOOP: All those in favor of the amendment
- 9 to reduce the allocation in 4A from 29,000 to 22,000 show of
- 10 hands?
- 11 (Commissioners Mohr and Boop raise hands.)
- 12 MRS. PALONE: Two, yes.
- 13 PRESIDENT BOOP: Those opposed show of hands.
- 14 (Commissioners Schreffler, Isabella, Riley, Palone,
- 15 Schleiden and Hill oppose.)
- 16 MRS. PALONE: Six oppose.
- 17 PRESIDENT BOOP: The amendment fails.
- 18 Any further amendment or discussion?
- 19 (No response.)
- 20 PRESIDENT BOOP: We move to 4B. Four (B) the
- 21 recommended allocation for 4B is 31,000.
- 22 Any comment or discussion on 4B?
- MR. MOHR: Four (B), Mr. President, is a notice to you
- 24 that it's pretty observant, it's quite obvious then that the

- 1 only difference between 4B and the other three that I mentioned
- 2 prior to this was 4B had a citizen advisory group and I would
- 3 sure hope by next year at this time we have a citizen advisory
- 4 group for every WMU.
- 5 Four (B) is the only one that's being recommended to,
- 6 in fact, allow the herd to increase with the allocation that
- 7 we're coming up with. It's quite obvious that that citizen
- 8 advisory group wants to recommend that.
- 9 PRESIDENT BOOP: Cal or Chris want to comment on those
- 10 comments?
- 11 (No response.)
- 12 PRESIDENT BOOP: Commissioner Palone.
- 13 MRS. PALONE: I just want to remind everyone that the
- 14 citizen advisory committee is just one part of a whole array of
- 15 factors that are taken into account on setting allocations. By
- 16 its very nature it's advisory. Even if you have citizen
- 17 advisory committees in each Wildlife Management Unit, the
- 18 Commission and agency is not bound to do exactly what they say.
- 19 They're just advisors.
- 20 PRESIDENT BOOP: Any other comments or discussion with
- 21 respect to the recommended allocation of 31,000 for 4B?
- 22 (No response.)
- PRESIDENT BOOP: If not, moving to 4C, recommended
- 24 allocation in 4C is 39,000.

- 1 Any discussion or comment with respect to 4C?
- 2 (No response.)
- PRESIDENT BOOP: Hearing none, goes to 4D. The
- 4 recommended allocation in 4D is 40,000.
- Is there any comment or discussion with respect to 4D?
- 6 (No response.)
- 7 PRESIDENT BOOP: If I could briefly offer some comment
- 8 with respect to 4D? It's pretty obvious that my making an
- 9 amendment with respect to 4D is not going to be met with any
- 10 success, so I'm not inclined to make the amendment. This is my
- 11 home area, the eastern part of 4D. I did not move given the
- 12 current climate to do anything about the Management Units this
- 13 year.
- But 4D, in my personal opinion, is the poster child
- 15 for a Management Unit that's too large. I hunt. I spend about
- 16 20-some days hunting turkey and deer in the eastern end of 4D.
- 17 This is an area where church groups are disbanding their events
- 18 and dinners, because no one in the congregation got a deer.
- 19 This is where you can hunt for a whole day without seeing a deer
- 20 and where one local sportsman's club is going to discontinue
- 21 their big buck contest for next year.
- The pain that this program is inflicting in this area
- 23 and the result in the loss of license sales, I just wish some of
- 24 you would spend a little time there. In light of the sentiment

- 1 with respect to the other amendments, I'm not going to offer an
- 2 amendment. It doesn't matter whether you make that 40,000 or
- 3 100,000, it's not going to change.
- 4 Yes?
- 5 MRS. PALONE: While I agree that some of the Wildlife
- 6 Management Units have increased or they've changed, I think this
- 7 is a good time to tell hunters that it's imperative that we send
- 8 in our hunter's report cards. If we have better data or more
- 9 data for each Wildlife Management Unit, in the future we may be
- 10 able to make it smaller. I think this year only 40 percent of
- 11 the people sent in their hunter's licensed report cards. It's
- 12 getting to the point now the participation is so low that in the
- 13 future if it gets lower we might have a little trouble
- 14 estimating things.
- So I would just ask for it to go on the record that we
- 16 really need to have an education, an information, something to
- 17 tell hunters why it's so important for us to send in our
- 18 hunter's report cards.
- 19 PRESIDENT BOOP: Any other comment or discussion on
- 20 the recommended allocation of 40,000 for 4D?
- 21 (No response.)
- 22 PRESIDENT BOOP: If not, moving to 4E. Four (E) the
- 23 recommended allocation there is 38,000.
- Is there comment or discussion with respect to 4E?

- 1 MR. MOHR: Four (E), Mr. President, is another WMU
- 2 that falls under the category of satisfactory, good, low. Staff
- 3 says they didn't have a problem with reducing the anterless
- 4 allocation there. It was made and they recommended 38,000. I'd
- 5 like to reduce that to 32,000 and that's my amendment.
- 6 PRESIDENT BOOP: Is there a second to the amendment?
- 7 I will second the amendment to reduce the allocation
- 8 from 38 to 32,000.
- 9 Is there discussion or comment on the amendment?
- 10 (No response.)
- PRESIDENT BOOP: Although my cabin and most of my
- 12 hunting is done in 4D, I personally live in 4E on a farm outside
- 13 of Sunbury. Four (E) encompasses almost all of Northumberland
- 14 County, a good portion of Columbia and Montour.
- 15 As Commissioner Mohr has noted, deer health is
- 16 satisfactory; habitat is good; and the allocation reduction that
- 17 he has proposed is a modest one from 38,000 to 32,000. There's
- 18 almost no human conflict. DMAP usage in that area is the
- 19 minimal. A lot of farm area.
- Where my farm is located and, certainly, a slight
- 21 increase in that area I think go a long way, a slight advantage
- 22 to some of our stakeholders in that area and, in my opinion,
- 23 have a minimal impact on both habitat and the deer herd health.

- 1 Is there any other comment or discussion on the
- 2 proposed amendment in 4E?
- 3 MR. SCHREFFLER: I have one comment to offer and that
- 4 is that this allocation for 4E has remained basically the same
- 5 for 2003, 2004, 2005 and again this year, always at 38,000.
- 6 PRESIDENT BOOP: Is there any other discussion or
- 7 comment on the recommended amendment in 4E to lower the
- 8 allocation from 38,000 to 32,000?
- 9 (No response.)
- 10 PRESIDENT BOOP: If not, those in favor of the
- 11 amendment indicate by raising their hand?
- 12 (Commissioners Schreffler, Mohr and Boop raise hands.)
- 13 MRS. PALONE: Three, Mr. President.
- 14 PRESIDENT BOOP: Those opposed?
- 15 (Commissioners Isabella, Riley, Palone, Schleiden and
- 16 Hill oppose.)
- 17 MRS. PALONE: Five, Mr. President.
- 18 PRESIDENT BOOP: All right so the amendment fails in
- 19 4E.
- Is there any other discussion, comment or further
- 21 amendment with respect to 4E?
- 22 (No response.)
- PRESIDENT BOOP: If not, moving to 5A, recommended
- 24 allocation in 5A is 25,000.

- 1 Is there comment or discussion with respect to the
- 2 recommended allocation in 5A?
- 3 (No response.)
- 4 PRESIDENT BOOP: Hearing none, we move to 5B. Five
- 5 (B), the recommended allocation for next year is 53,000.
- Is there comment or discussion with respect to the
- 7 recommended allocations for 5B?
- 8 MR. MOHR: Mr. President, 5(B) is a Management Unit
- 9 that I actually reside in. Another example where deer health is
- 10 good, habitat is listed as satisfactory. I'd like to challenge
- 11 somebody to show me why that's satisfactory and not good.
- 12 That's Lancaster County, York County and in those counties we
- 13 don't need one ounce of forest land to grow deer. We just need
- 14 to fence roads and brushy hillside and the farmers that are
- 15 willing to feed them.
- 16 Right now we have all of those. I get complaints
- 17 whenever deer come up. I get complaints even on the farmers
- 18 they don't have enough deer. I personally let five acres of
- 19 corn stand for the deer this year and not one single deer was
- 20 seen in that corn since the first of January.
- 21 I'd like to make an amendment here that that number be
- 22 reduced 40,000 for the antlerless allocation.
- 23 PRESIDENT BOOP: Is there a second to Commissioner
- 24 Mohr's amendment?

- 1 I will second the amendment.
- 2 Is there discussion or comment on the amendment?
- MR. SCHREFFLER: Mr. President, does the staff have an
- 4 actual land use figure for this and is that accurate?
- 5 MR. DUBROCK: We do and this particular unit is 63
- 6 percent in ag and open field land use, so basically two out of
- 7 every three acres. Seven percent of it's developed. It's one
- 8 of the most rapidly developing areas of the Commonwealth, as
- 9 well.
- 10 MR. SCHREFFLER: Are we hearing a lot of complaints
- 11 with human-deer conflicts here, with the people landscaping, his
- 12 lawn being eaten up?
- 13 MR. DUBROCK: Well, as evidenced by DMAP
- 14 participation, we are not. Anecdotally, I would I guess defer
- 15 to the Regional Director in that area to know about complaints
- 16 that his officers are dealing with. But I would say, no,
- 17 generally speaking.
- MR. SCHREFFLER: Is that a concern of yours?
- MR. DUBROCK: I think the concern always is in this
- 20 particular area it's a matter of what people are willing to
- 21 tolerate. As we drop allocations and increase populations, the
- 22 deer population will increase and they need to be supported on
- 23 that landscape.

- 1 So it likely would exert more pressure on the
- 2 predominate land use, which in this area is agriculture. That
- 3 would be a consequence. Whether it reaches a level of
- 4 intolerance, I think is difficult to predict.
- 5 MR. SCHREFFLER: In response to Commissioner Mohr, I
- 6 could go along with some of an increase here, but not quite as
- 7 much as he suggested. I don't think, I think that is maybe so
- 8 large an increase that we're going to leave ourselves open for a
- 9 lot more conflict in the future with the human-deer conflict and
- 10 the socially acceptable levels are going to put more pressure on
- 11 this in the future.
- 12 PRESIDENT BOOP: I think that Commissioner Mohr's
- 13 amendment is on the table and we're offering and that's comment
- 14 on that, of course, Commissioner Schreffler, and we're going to
- 15 vote on this amendment. There may be a subsequent amendment,
- 16 but is there any further discussion or comment on this proposed
- 17 amendment?
- 18 MR. MOHR: Cal, when I asked you to come up with a
- 19 figure to actually increase the herd somewhat, how did you
- 20 determine that 40,000 was the allocation that we needed to use?
- 21 MR. ROSENBERRY: That increase would be about a deer
- 22 per square mile across that entire unit, is what we would expect
- 23 that allocation, the result of that allocation would be an
- 24 increase.

- 1 PRESIDENT BOOP: The 40,000 figure.
- 2 MR. ROSENBERRY: About a deer per square mile across
- 3 the entire unit.
- 4 PRESIDENT BOOP: Any further comment or discussion on
- 5 the proposed amendment?
- 6 (No response.)
- 7 PRESIDENT BOOP: If not, we're voting on the amendment
- 8 to reduce the allocation in 5B, recommended allocation from
- 9 53,000 to 40,000. Let's see a show of hands that support that
- 10 amendment?
- 11 (Commissioners Boop and Mohr raise hands.)
- 12 MRS. PALONE: Two, Mr. President.
- PRESIDENT BOOP: Opposed?
- 14 (Commissioners Schreffler, Isabella, Riley, Palone,
- 15 Schleiden and Hill oppose.)
- 16 MRS. PALONE: Six, Mr. President.
- 17 PRESIDENT BOOP: The amendment fails.
- 18 Is there any additional amendment with respect to the
- 19 recommended allocation number of 53,000?
- 20 MR. SCHREFFLER: I'll make that additional amendment
- 21 that we change the allocation to 46,000.
- 22 PRESIDENT BOOP: Commissioner Schreffler has made a
- 23 motion that the recommended allocation of 53,000 in 5B be
- 24 reduced to 46,000. Is there a second to that amendment?

- 1 MR. MOHR: Second.
- 2 PRESIDENT BOOP: Is there discussion or comment on
- 3 that amendment?
- 4 (No response.)
- 5 PRESIDENT BOOP: Hearing none, all those in favor of
- 6 Commissioner Schreffler's amendment to reduce the allocation to
- 7 46,000, show of hands?
- 8 (Commissioners Schreffler, Boop and Mohr raise hands.)
- 9 MRS. PALONE: Three.
- 10 PRESIDENT BOOP: Opposed?
- 11 (Commissioners Isabella, Riley, Palone, Schleiden and
- 12 Hill oppose.)
- 13 MRS. PALONE: Five. The amendment fails.
- 14 PRESIDENT BOOP: The amendment fails.
- 15 Is there any further discussion or further amendment
- 16 on the allocation number for 5B?
- 17 (No response.)
- 18 PRESIDENT BOOP: Hearing none, we move to 5C. Five
- 19 (C), the recommended allocation number is 79,000. Is there
- 20 comment or discussion on that allocation number for that
- 21 Management Unit?
- 22 (No response.)
- PRESIDENT BOOP: Hearing none, we move to 5D.

- 1 The recommended allocation number for 5D is 20,000.
- 2 Is there comment or discussion on that allocation number?
- 3 MR. SCHREFFLER: I have one question. Do we sell out
- 4 our antlerless allocations?
- 5 MR. ROSENBERRY: No, not in 5D.
- 6 PRESIDENT BOOP: Any other question or comment?
- 7 (No response.)
- 8 PRESIDENT BOOP: That completes the individual review
- 9 of 22 Management Units.
- 10 Commissioner Palone can correct me, but I think all
- 11 amendments failed in those that were offered, so we're now down
- 12 to taking a vote on the allocation numbers for each of the 22
- 13 Management Units as set forth in what was presented yesterday
- 14 afternoon and what we reviewed for this morning.
- 15 So I think by a show of hands we'll vote on the
- 16 allocation numbers for 2006/2007. All those in favor--
- 17 MR. MOHR: Comment, Mr. President, before we vote.
- 18 PRESIDENT BOOP: Sure.
- 19 MR. MOHR: I'd like to make a comment. The numbers
- 20 that we're voting on and the apparent disregard for political in
- 21 putting all the faith into science, the social aspect's been
- 22 disregarded. I know there's going to be ramifications for this
- 23 vote. I just hope that the hunters and those folks that are

- 1 disappointed in the vote do realize that they did have some
- 2 voice here.
- 3 Yesterday one of the Commissioners made the statement
- 4 that hunters don't have much clout politically in Pennsylvania.
- 5 So I guess we'll know next year at this time when you have to
- 6 bring your candles in, your flashlights along in here they may
- 7 have had more clout than you thought. And I'm not sure the
- 8 Governor is in agreement with that, those positions.
- 9 MR. RILEY: Mr. President.
- 10 PRESIDENT BOOP: Mr. Riley.
- 11 MR. RILEY: Hunters always have clout. They always
- 12 have had clout. That's just baloney. We have clout. We're
- 13 following the science because for the last 70 years the science
- 14 has failed. Every time we got to the threshold, all of you
- 15 know, you read the 1895 to 1995, you know the heartbreak for all
- 16 of us through those years.
- 17 This Board has taken a oath to do something positive
- 18 for this problem. The majority of these Commissioners are
- 19 living by that vote, in my judgment. It has to stop or our
- 20 grandchildren will never know what deer hunting is. We cannot
- 21 bring social and the legislative legs into this equation when
- 22 the resource and the habitat are not matched. It's foolhardy.
- We all enjoyed the good years when we saw 40 or 50
- 24 deer a day. We all anticipated, even though science and the

- 1 written word proved otherwise, but we disregarded that. We know
- 2 the famous story about Roger Latham back in 1953, when he wrote
- 3 his article in the Game News. It's too late, gang. It's too
- 4 late. You've waited too long. In 50 years you will have
- 5 negatively impacted the white-tailed deer hunting in the State
- 6 of Pennsylvania to a point of where we're at today.
- 7 History repeats itself. The history books are full of
- 8 those little sayings about those who ignore history. We are
- 9 doing something positive for the next generation. We have to
- 10 manage. Just like we had a pasture for ten cows, you put a 100
- 11 cows in that pasture you lose the pasture and the cows.
- The habitat and the herd have to be balanced and we
- 13 are responsible for that. That's the whole of this Commission.
- 14 I think that we did the proper thing. I don't take kindly to
- 15 Commissioner Mohr's remarks. We have done the right thing. We
- 16 followed the science. That's why we have biologists.
- 17 The hunter does count. We're all hunters. We want to
- 18 be counted, but we have to be responsible. There's a deer herd.
- 19 There's habitat and there's conflict. We have to manage them,
- 20 just like we've managed our families, managed our businesses,
- 21 managed our ball teams, managed our nation. It is our
- 22 responsibility. Hopefully, this will go in the history book as
- 23 this Board of Commissioners taking their responsibility very
- 24 seriously.

- 1 Thank you, Mr. President.
- 2 MR. SCHREFFLER: Mr. President, may I speak?
- 3 PRESIDENT BOOP: Sure.
- 4 MR. SCHREFFLER: I have a few comments to say.
- 5 First of all, I want to make public my thanks to the
- 6 field staff, the WCOs, the land managers, the foresters around
- 7 the state for the extra time they put in this year in trying to
- 8 get some data to us from the field on deer numbers, mass
- 9 production forest regeneration and so on and their analytical
- 10 data that they gave us with that.
- 11 Also, for the data supplied by a lot of hunter,
- 12 landowners, which I appreciated. It wasn't just hearsay or
- 13 wrong, but it was some good data that I got.
- I also want to make mention that this is the first
- 15 year that we're beginning to use the preliminary figures from
- 16 our new measures. The first year starting to do that. This is
- 17 the first year that we're beginning to make a prescription by
- 18 Wildlife Management Unit. Whether they're too big or not,
- 19 that's what we have to live with now. We're trying to describe
- 20 points of the conditions there.
- I want to thank the team for doing an excellent job.
- 22 We asked them to give us data that would be defensible, data
- 23 that was backed up and with peer review how they came to that
- 24 data. There was peer review and put out there. All of this

- 1 information we asked the staff to put out on the Web and put out
- 2 to the public so that everyone would see how we came to these
- 3 figures.
- 4 That's a big, a big, big matter of trust to each and
- 5 every one of you from our deer team that we will look at those
- 6 objectively and fairly. They did an excellent job, because I
- 7 think that when you understand how we come to these conclusions
- 8 and how we get there, that you will realize the validity of it.
- 9 If it's not out there so that the public can see what we're
- 10 doing and it's secret or it's not made available to you, that's
- 11 when we have the fear that we're not doing the right thing.
- 12 I really think the Deer Team has put a great deal of
- 13 trust in you, the public, to fairly evaluate how they come to
- 14 this. They've been very conscientious.
- We have made a number of other changes, which I had
- 16 heard we are following the same old policy. No, we threw out
- 17 the old deer population model. We're coming up what new
- 18 performance measures. We're changing and tweaking the system
- 19 all the time, trying to improve, trying to respond to your
- 20 criticisms and your suggestions.
- I like especially myself, personally, to hear the
- 22 suggestions. Criticism is very easy, but I like suggestions.
- So I think that we've got a good product here. We're
- 24 not all happy with it. We wanted some emotion. We wanted some

- 1 things to be different. Intellectually, conscientiously, and
- 2 following our oath to put wildlife out there so that the hunters
- 3 have something to hunt down the future, looking at the big
- 4 picture down the road, we have sometimes -- we're put in the
- 5 position we have little or no other choice and it goes one way,
- 6 which is obvious.
- 7 So, again, my thanks to those people. This have been
- 8 a very tough decision. We put in a lot of hours. At times when
- 9 I thought I would be working two hours I ended up working eight
- 10 to ten on whatever it may have been and just working through
- 11 this.
- 12 Thanks to those people again and thanks to the Deer
- 13 Team and I hope you all appreciate the seriousness that we all
- 14 take for this decision.
- 15 PRESIDENT BOOP: Anyone else?
- 16 Commissioner Palone.
- 17 MRS. PALONE: Thank you, Mr. President.
- 18 First of all, I want to say that I think the deer
- 19 debate in Pennsylvania is changing. Ten years ago we didn't see
- 20 or hear much written about deer, except in the outdoor magazines
- 21 and outdoor newspaper. But today the talk of the deer is on
- 22 everyone's television and radio shows. It's in community,
- 23 township and borough meetings. There's community seminars about
- 24 deer and the general public has really been noticing deer.

- 1 These folks, I believe, speak as one voice and they're
- 2 united. There's been various organizations springing up to
- 3 support their cause. I believe in the future they'll be a
- 4 probable course to be reckoned with. I think as hunters we need
- 5 to get back to our conservationist's routes. We're very
- 6 personalized and that makes us vulnerable to some of these
- 7 people who don't hunt and don't share our traditions.
- I think that we must stop managing deer based on
- 9 opinion and emotion, because these are the same tactics that the
- 10 animal rights people use. Sometimes I think that we want to
- 11 take the easy way out and want instant gratification, but really
- 12 there's no easy way out.
- 13 It took us decades to get into this mess and I think
- 14 it's reasonable to ask our hunters just for a few years to be
- 15 patient to get out of this mess. I think we brushed aside
- 16 sensible methods of correcting to over grazing year, after
- 17 year, after year and now the turkey has come home to roost.
- 18 By most accounts there appears to be the start of a
- 19 recovery of our habitat, but I think we should continue this
- 20 recovery. I don't think we should do it with rhetoric or trying
- 21 to place blame, but I think we need to use the best signs that
- 22 is out there.
- I think for decades that many of us, including
- 24 Commissioners, and some of the journalists, and legislators and

- 1 others who report to this issue have really sought favorable
- 2 headlines rather than doing what has to be done. Now that we're
- 3 nearly there I think that no one's position or even friendship
- 4 should take precedence over doing the hard right.
- 5 I don't think that we could pass this burden on to the
- 6 next generation again. Mr. Riley talked about that. I think we
- 7 need to have the courage and leadership to finish this process,
- 8 because we as Commissioners and as hunters are the last line of
- 9 defense. We Commissioners asked for this responsibility and I
- 10 think we should show that we can finish the job.
- We have been asked to emphasize social and political
- 12 factors, but I feel like we've tried that for decades and that
- 13 it failed. I believe in my heart that it's time to put biology
- 14 at the top of our decision making process, at the very top.
- 15 It's time to give them a chance to help us rectify some of these
- 16 deer problems.
- 17 I'm confident that the day will come and parts of this
- 18 day where we can increase the herd a little bit and it will
- 19 still be sustainable, but I don't think that day is today.
- 20 PRESIDENT BOOP: I think we've heard from most
- 21 Commissioners.
- 22 Commissioner Hill or Commissioner Schleiden, do either
- 23 of you want to comment before we vote?
- MR. SCHLEIDEN: I have nothing to add, sir.

- 1 PRESIDENT BOOP: Commissioner Hill?
- 2 MR. HILL: I have nothing to add at this time.
- 3 PRESIDENT BOOP: One of the benefits that I personally
- 4 feel that I have is that I've been trained as a lawyer. As a
- 5 lawyer, I bring the prospective that unanimous votes usually are
- 6 not in the best interest of organizations. I think that to get
- 7 to the right point by debating the issue and sharing their
- 8 concerns and making the other person justify their position.
- 9 So I think that on an issue as this issue has been
- 10 concerning deer management that an 8-0 vote probably is not in
- 11 the best interest of the Commission or the Commonwealth. I
- 12 don't want to incur Commissioner Riley's wrath, but I have a
- 13 very different view or the issue and I'm in the minority. I
- 14 think that history will prove who was right and who was wrong
- 15 and I'm willing to trust that to history.
- 16 I also am a student of history and history is full of
- 17 examples of people who thought they were right and lost the war.
- 18 I think maybe we do need to take a look at our structure that we
- 19 have here. I think all Commissioners took the same oath, all
- 20 Commissioners are trying to do the right thing.
- 21 I think personally we've given the forestry community
- 22 a pass on this issue. I wish that some of you in the writing
- 23 community would direct the same attention to the forestry

- 1 practices in this state that you directed to this Commission and
- 2 how we've managed the wildlife.
- I think by blaming everything on deer and accepting
- 4 that deer are the root of all evil in the forest, is just giving
- 5 a couple other industries a buy. I wish that some of you would
- 6 direct some attention in that area and see if their practices
- 7 will stand up to the scrutiny that our practices have stood up.
- 8 Unfortunately, the structure is that two-thirds of our
- 9 income is on the hunters unless someone in another place, in
- 10 another time is going to change that. I think that some of us
- 11 on the Board felt that we at least had to consider backing you
- 12 as well.
- The decision has apparently been made. I think we all
- 14 try to do the right thing. It's not personal. I'm personally
- 15 friendly with all of the Commissioners and it will be that way a
- 16 half-hour from now.
- 17 So we're going to vote and the vote is on the
- 18 anterless allocations as presented for 2006/2007.
- 19 All those in favor of the allocations for the 22
- 20 Management Units as proposed, indicate by raising their hands.
- 21 All those in favor?
- 22 (Commissioners Schreffler, Isabella, Riley, Palone,
- 23 Schleiden, and Hill raise hands.)
- 24 PRESIDENT BOOP: All those opposed?

- 1 (Commissioners Boop and Mohr oppose.)
- MRS. PALONE: Six in favor, two opposed.
- 3 PRESIDENT BOOP: That concludes that portion of the
- 4 business meeting.
- I would like to offer a few thanks before we leave
- 6 today. We did ask the Deer Management Team to provide the Board
- 7 with more detailed data on each Management Unit. I think they
- 8 worked very hard to do that. It's presented in a fashion that
- 9 is certainly understandable.
- 10 Although some of us didn't agree with what was
- 11 presented, we feel that they did comply with what we asked them
- 12 to do, so I'd like to make a sincere, personally thank Dr.
- 13 Rosenberry and his team for the work that you did.
- I also know the other issue that generated a lot of
- 15 discussion was the subject of a lot of interest for those of you
- 16 in the audience is our mentor hunt that we'd like to complement
- 17 and recognize all of you who worked so hard on getting that
- 18 together. Just bear with us a little bit. We wanted you here
- 19 too and we want you here next year. Please give us a little
- 20 time to get that all in place.
- 21 Our next meeting will be held here in Harrisburg in
- 22 June. I believe the dates are the fifth and sixth of June, and
- 23 that will be our next meeting.

- 1 Do any of the Commissioners have anything to add
- 2 before I ask for a motion to adjourn?
- MR. MOHR: Mr. President, we've been contacted for the
- 4 last several years for individuals wanting us to allow peep
- 5 sights to be used on the flintlock. We presently allow fiber
- 6 optics, which is far modern than peep sights. I'd like to have
- 7 the Law Enforcement Committee initiate, look into that to allow
- 8 peep sights to be put on.
- 9 One other thing I'd like to ask the Executive Director
- 10 if he could initiate, see that next year by the October meeting
- 11 there's an advisory committee for each Wildlife Management Unit.
- 12 PRESIDENT BOOP: I think Commissioner Mohr's comments
- 13 are duly noted.
- 14 Any other Commissioners have any comments or requests
- 15 before we adjourn?
- 16 (No response.)
- 17 PRESIDENT BOOP: Commissioner Isabella, are you still
- 18 there?
- 19 MR. ISABELLA: Yes, I am, Mr. President.
- 20 PRESIDENT BOOP: We wish you well and wish your wife
- 21 for a recovery.
- MR. ISABELLA: Thank you, Mr. President.
- PRESIDENT BOOP: Mr. Roe, anything?
- 24 (No response.)

1	PRESIDENT BOOP: I'll entertain a motion to adjourn?
2	PRESIDENT BOOP: Commissioner Riley.
3	MR. RILEY: So moved.
4	PRESIDENT BOOP: Is there a second?
5	MRS. PALONE: Second.
6	PRESIDENT BOOP: All in favor?
7	(Signified aye.)
8	PRESIDENT BOOP: We're adjourned.
