The Pennsylvania Game Commission must receive this application by **Aug. 14**. We do our best to accommodate all appropriate requests but cannot guarantee every organization will receive birds. Birds will be distributed on a first come, first served basis at a rate of two legal birds per registered youth participant. **The number of birds assigned to the hunt will be determined by the number of youths registered for the hunt event on the deadline of September 24, 2021.**

Organizations receiving birds are REQUIRED to:

1. Follow the Game Commission's recommended guidelines for releasing birds (*Failure to comply with these guidelines may result in disqualification from future grant opportunities.*)
2. Register participants through the Event Manager System.
3. Confirm with the Game Commission the number of youths who will be participating in the event by no later than **September 24**. This is required to plan the distribution of birds.
